14. PRE-QUALIFICATION REQUIREMENT:-

Bidders are requested to fill up the details in "TECHNICAL AND FINANCIAL PRE-QUALIFYING REQUIREMENT" and also to submit the credentials. The bidders, who are already registered with BHEL PEM for the tendered package *without any technical/financial limit*, need not submit the Technical/ Financial PQR. They will be considered qualified on Technical/ Financial PQR based on their registration with BHEL PEM. In case of limit, the registered bidder may submit the documents required for review of limit alone, if the bidder wants re-assessment of the limit.

Bids of only those bidders shall be evaluated who meet the Technical as well as Financial pre-qualifying requirements. Credentials of the bidders meeting the prequalifying requirements shall be taken up with customer for approval. Price Bid of only BHEL and customer approved vendors shall be opened and same shall be covered in NIT.

15. **Reverse Auction:** BHEL/ PEM reserves the right to go for Reverse Auction, through BHEL appointed service provider, instead of opening sealed price bids submitted along with Part-I. This would be decided after techno-commercial evaluation. (Refer Clause No. 15.0 of Instruction to Bidders, GCC REV 05).

16. Bidder to note for compliance that this is conditional enquiry, the price bid (Part-II) opening/RA is subjected to

18. The following Terms & conditions shall be applicable for the subject package:

- i. **Price Variation:** PVC shall be payable on the date of despatch in the ratio of 1:1 based on Nalco IC 20 Grade Aluminium Ingot. NALCO IC 20 Grade Ingot rate is available on internet on NALCO site, which shall be followed. While quoting, vendor has to confirm the base NALCO IC 20 Grade Ingot rate. Price offers of all the bidders shall be evaluated on the same base rate of Ingot. PVC formula as above shall be operated for bringing all price offers on same Ingot base rate.

Prices are variable on PVC (1:1 variation with the base date & rate to be submitted by the vendor with documentary proof.

- ii. Dispatch tolerance : +3% for Quantity more than 10 MT. & +5% for Quantity up to 10 MT
