4. Solvency certificate shall be minimum of 40 % of value of respective work indicated above.

**Note:- CONTRACTORS WHO HAVE REGISTERED IN BHEL, TIRUCHY WITH REQUIRED MONEY LIMIT FOR THE SAID VALUES NEED NOT SUBMIT THE DOCUMENTS CALLED FOR IN THE QUALIFICATION BID. HOWEVER THEY HAVE TO SIGN AND SUBMIT THE QUALIFICATION BID ALONG WITH PRICE BID.**
