1.The 45% of the Bidder`s quoted lumpsum value shall be allocated towards the deployment of T & Ps and the balance 55% shall be allocated for the works and other services like manpower, T& Ps other than cranes (like Jacks, Sleepers for unloading by Rigging method etc) and trailer etc..Bidders are to note that Only the value of this 55% will be taken into account for the purpose of quantity variation, Over run compensation and Price variation clause.

2.The percentage of allocation per month per item to be considered for the purpose of payment for the cranes and trailers deployed is mentioned against each T & P

3.There shall be no separate charges for reshifting and restacking of materials. Any number of times Reshifting / Restaking is required for upkeep of MM, Bidder shall carry out the same within the quoted lumpsum price.
