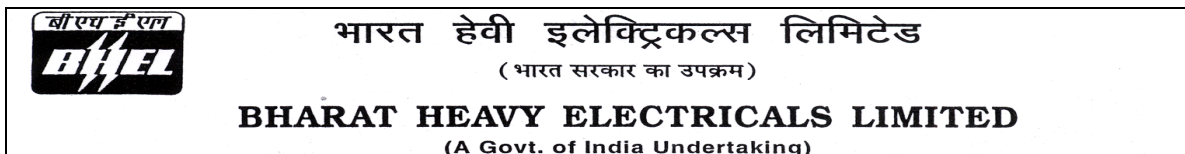

3.	Technical support in the use of software by email / fax / phone / letter correspondence / minimum of one visit of technical expert for every year during ALF period.
4.	Price: in the specified format / details given in the technical specification no.: PEMC-04292. (Price would be best possible discount for BHEL and should carry the documentary evidence of earlier POs / LOs placed by any other BHEL Units / any public sector / any big private sector companies)
5.	Taxes: Applicable Taxes if any, should be explicitly mentioned. Otherwise prices quoted are considered as inclusive of all applicable taxes.
