1. DETAILS OF THE JOB: We intend to off-load finish machining of 3DS Moving & Lock blades of above subjected Projects. The details of the job are given in Annexure-G.

2. QUANTITY: 12842.

3. QUOTATION: You are requested to submit your quotations in two bids separately as per the conditions laid down in ANNEXURE – X

A. Techno – Commercial Bid (Unpriced): A check list format (annexure-A) is enclosed for ready reference of these conditions and submission of the bid. It is to be sealed in a cover super scribing “Techno-commercial bid”, Enq no. and Due date.

Please read the important terms and conditions carefully.

B. Price Bid: Price bid format (annexure-B) is enclosed and price is to be quoted in the same format. It is to be sealed in a cover super scribing “price bid”, Enq no. and Due date.

Your two sealed bids are to be sealed in a bigger cover super scribing the enquiry no. and due date, and it should reach us on or before **27.07.2016 by 11.00 Hrs.** to the following address.

**Reverse Auction:** BHEL reserves the right to go for reverse auction (RA), instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA. In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'online sealed bids' in the Reverse Auction. Non-submission of 'online sealed bid ' by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant Movinglines in vogue. Terms and Conditions of RA are contained in Annexure-XX  
Business rules for RA are contained in Annexure-YY.

4. **TERMS OF PRICE:** -

- a) Rates to be quoted per piece considering net of scrap, as no process scrap will be collected by BHEL.
- b) Rates to be quoted F.O.R. BHEL Hyderabad – 32.
- c) No Tools / Cutters will be supplied by BHEL.
- d) The prices are valid for three months from the date of opening of tender. However, as the orders may be released on staggered basis, the finalized rates shall be valid for a period of three ( 3) months from the date of finalization of rates.
- e) Rejection rate not to be more than 2% allowed, and rejected blades should be returned to BHEL along with accepted blades and no conversion charges will be paid for rejected blades.
- f) The required Raw Material will be issued by BHEL as free issue and the same shall be collected by the vendor from BHEL Hyderabad store. Normally the optimum sizes of the Raw Material will be supplied. If optimum size material is not available next higher size flat will be supplied.

5. **CLARIFICATION:** -If any further clarification is required, you may please depute your representative for discussion before submitting your quotation.

6. **DRAWINGS:** -We are enclosing here with drawings for reference purpose, which are not to be shared with others.

7. **TENDER OPENING:** Quotation should reach us by 11.00 hours on the due date. Tenders will be opened by the concerned Finance Manager of BHEL Hyd-32 at 13.30 Hours on the due date in the presence of such of those tenderers who may be present.

8.      DESCRETION OF ACCEPTANCE: BHEL reserves the right to accept or reject any tender or a proportion thereof without assigning any reason what so ever. Further BHEL has full discretion to distribute the contract quantity to more than one firm in any proportion deemed fit and no minimum load guarantee can be given by BHEL.
9.      Vendor shall be liable for recovery of the cost of raw material, in case of any mix-up noticed during processing / final usage.
10.     It shall be the responsibility of the Sub-Contractors to check the raw material received by them both for quantity and quality as mentioned in the order and bring out any discrepancy to our notice within three days of material supplied.
11.     BHEL shall have the right to cancel any contract either wholly or in part, in case it is obliged to do so on account of any decline, diminution, curtailment or stoppage of BHEL's business.
12.     BHEL reserves the right to cancel the contract either wholly or in part without assigning any reason what so ever.
13.     On receipt of material at BHEL, if any further / hidden defects are noticed, the same shall be attended to by the vendor at his own cost.
14.     All legal matters shall be settled under the jurisdiction of Court at Sanga Reddy, Medak District, and Telangana.
15.     Only those vendors who respond to this tender will be considered for placement of orders.
16.     All other conditions, as per BHEL standard regulations for the issue of Sub Contract Order shall also apply.
