SPECIAL TERMS AND CONDITIONS

1. The offer has to be submitted in **TWO PART BID** on or before the due date. In case the due date will be a closed holiday then the tender will be opened on next working day.

**PART 1- Technical & Commercial (Unpriced bid) in a sealed cover****PART 2- Price Bid in a separate sealed cover**

Both the above sealed covers should be put in another sealed cover. All the covers should be super-scribed with Tender No., due date and Description of the item.

2. Please quote the price **"on FOR destination"** basis inclusive of testing, packing & Forwarding, Freight and insurance.
3. Rates quoted shall be inclusive of all taxes, duties, including octroi, entry tax etc. on FOR Destination. Supplier should furnish **ED details** separately in their offer / invoice, for BHEL to avail CENVAT benefits. We will not furnish any 'C' Form. ED value will not be considered while comparing offer for arriving at "L1".
4. Evaluation will be on total sum basis excluding CENVAT benefits.
5. BHEL reserves the right to go for reverse auction instead of opening the submitted sealed bid, which will be decided after technical evaluation. As such the bidders should submit their best price in the sealed bid. Bidders are requested to furnish following details in their techno commercial bid for the purpose of RA. All bidders to give acceptance to participate in Reverse Auction. Non acceptance to participate in RA may result in non consideration of their bids, in case BHEL decides to go for RA. In case BHEL decides to go for RA, only those bidders who have given their acceptance to participate in RA will be allowed to participate.



**GENERAL TERMS AND CONDITIONS OF REVERSE AUCTION (RA)**

Against this enquiry for the subject work, tender may be processed through Reverse Auction mode i.e., ON LINE BIDDING ON INTERNET. The General Terms and conditions of the RA shall be as follows:

1. For the proposed reverse auction, technically and commercially acceptable bidders only shall be eligible to participate.
2. Those bidders who have given their acceptance for RA (quoted against this tender enquiry) will have to necessarily submit "on line sealed bid" in the RA. Non submission of on line sealed bid" by the bidder will be consider as tampering of the tender process and will invite action by BHEL as per extent guide lines in vogue".
3. BHEL will engage the services of a service provider who will provide all necessary training and assistance before commencement of on line bidding on internet.
4. In case of reverse auction, BHEL will inform the bidders the details of Service Provider to enable them to contact & get trained.
5. "Business rules' like event date, time, bid decrement extensions etc., also will be communicated through service provider for compliance.
6. Bidders have to fax the Compliance form (annexure-IV) before start of Reverse auction. Without this the bidder shall not be eligible to participate in the event.
7. In line with the NIT terms, BHEL will provide the calculation sheet (eg., EXCEL sheet) which will help to arrive at "Total Cost to BHEL' like packing & forwarding charges, Taxes and duties, Freight charges, Insurances, Service Tax for services and loading factors (for non compliance to BHEL standard commercial terms and conditions) for each of the bidder to enable them to fill in the price and keep it ready for keying in during the Auction.
8. Reverse auction will be conducted on scheduled date & time.
9. At the end of Reverse Auction event, the lowest bidder value will be known on auction portal.
10. The lowest bidder has to Fax / e-mail the duly signed Filled-in prescribed format for price breakup including that of line items, if required (Annexure- VII) as provided on case-to-case basis to Service provider within two working days of Auction without fail.
11. In case BHEL decides not to go for Reverse Auction procedure for this tender enquiry, the price bids and price impacts, if any already submitted and available with BHEL will shall be opened as per BHEL's standard practice.
12. Bidders shall be required to read the "Terms and Conditions" section of the auction site of service provider, using the Login IDs passwords given to them by the service provider before reverse auction
