10. Reverse Auction:

Bidders to quote their best competitive prices. BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit online sealed bid in the Reverse Auction. Non-submission of online sealed bid by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.

Terms & Conditions of Reverse Auction shall be as per attached annexure-I.

11. Delivery Schedule:

For Mandatory Spares:-

"Delivery for Mandatory spares shall be '30 sep 2017' or 04 months from the date of manufacturing clearance, whichever is later. Separate dispatch/ manufacturing clearance will be issued for mandatory spares as per SCC.

For E & C: - Eight (08) months from the date of site front availability. Site front availability is "Date for which site informs for mobilization shall be date of clearance of front".

12. Pre-Qualifying Requirement:

Bidders who fulfil TECHNICAL & FINANCIAL PRE-QUALIFICATION REQUIREMENT CRITERIA are eligible to participate in this tender.

Bidders are requested to provide the details as per "TECHNICAL & FINANCIAL PRE-QUALIFICATION REQUIREMENT". Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.

14. If any bidder has mentioned the term **Not Applicable / Not required / Not Quoted** in BHEL price format. The bidder needs to substantiate the same. If the same item will be required in future for the system same will be supplied free of cost.
15. Vendor shall have to enter into Integrity Pact with BHEL. The integrity pact, shall be returned by the bidder, along with their Techno-Commercial Bid, duly filled and signed by the authorized signatory and will form part of the order. Only those vendors/bidders who enter into Integrity Pact with BHEL would be qualified to participate in the bidding process. **In other words, entering into this Integrity Pact would be a preliminary qualification.** (Refer Annexure-IX, as per GCC Rev 06).
To oversee implementation of Integrity Pact, **Mr. D.R.S Chaudhary, IAS (Retd.)** has been appointed as Independent External Monitor (IEM) by BHEL.
16. Deviations (Commercial as well as Technical) from NIT are generally not acceptable. In case of deviations from NIT, the tenderer shall give cost of withdrawal of such deviations in sealed cover as per annexure-II of GCC Rev 06. (Deviation Sheet (Cost of withdrawal))
17. Total erection & commissioning charges & PG Test and handing over charges (including service tax) should be minimum 20% of the total quoted package (excluding mandatory spares but including all taxes & freight), failing which the break-up of price shall be adjusted accordingly for ordering.
18. Bidder to note that this is a conditional Open Tender enquiry and the price bid (Part-II) opening/ RA participation shall be subjected to following criterion:

a). **Techno-commercial qualification / recommendation of bidder by the BHEL-PEM.**

b). **Approval of bidder by customer**

Approval shall be taken up by BHEL with customer based on the credentials / reference list. Hence, bidders are requested to submit the following (a part of their credentials) on or before Part-1 opening / due date:-

19. Any other taxes & Duties applicable on the date of bid but not quoted by the bidders shall be to bidder account.
20. Indian Bidders/ Foreign Bidders for indigenous items have to quote freight charges in percentage of their quoted Total Ex-works prices.
21. Bank Guarantee (BGs) should be in the name of BHEL PS-WR in place of PEM. Vendors will be required to submit the BGs to executing agency BHEL PS-WR.


