13. Bidders to note that this is a conditional enquiry for those who are not registered with BHEL- PEM, the price bid (Part-II) opening/RA shall be subject to approval of bidder by the BHEL.

The bidders which are not registered with BHEL-PEM, refer Supplier Registration Form (SRF) attached with enquiry and submit the same duly filled (with signed & stamped) in along with credentials, experience list, performance certificates and other statutory data with their bids for vendor registration.

14. **Points regarding CIF Content :-**

a) **For Mouda Project :** Bidders to quote their import content (CIF), if any in their price bid (Refer Annexure -CIF of Price Schedule). BHEL shall inform the availability of CIF value for the package including ceiling limit, if any, during evaluation of offer.

b) **For Gadarwara Project :** Please be informed that No CIF allocation is available for this package.

15. **Indigenous bidders have to quote freight charges in percentage of their quoted Total Ex- works prices.**

16. BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'online sealed bid' in the Reverse Auction. Non-submission of 'online sealed bid' by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.

Bidders are requested to refer '**Annexure-I to Terms & Conditions of Reverse Auction**' attached along with tender enquiry.

17. All the above Tender Documents shall automatically become a part of the Order/Contract after its finalisation.
18. Evaluation will be done on overall L1 (Total cost to BHEL i.e, F.O.R. Site Price) basis **for each Project.**
19. Indigenous bidders have to quote F.O.R. site prices and foreign bidders to quote their F.O.B. port price. However, F.O.R site prices for foreign bidders will be calculated by loading their F.O.B. port price as per GCC, Rev.06.
20. Bidders are requested to visit our website on regular intervals to update themselves for any technical or commercial change in the NIT.


