2. The bidders (who are not registered with BHEL-PEM) has to download the Supplier Registration Form (SRF) from www.bhel.com / [http:// www. bhelpem.com/ Vendor%20Corner.aspx](http://www.bhelpem.com/Vendor%20Corner.aspx) and submit the same duly filled in along with credentials-experience list, performance certificates and other statutory data to our Vendor Development section with intimation to us.

3. Bidders has to note that TERMS AND CONDITIONS of the tender shall be as per General Conditions of Contracts (GCC, Rev. 06), Special Conditions of Contract of respective Projects and as per these Notice Inviting Tender (NIT) conditions. 6. Combined Evaluation (for both SG & TG PACKAGES) will be done on overall L1 (Total cost to BHEL) basis. Bidder to refer SCC & GCC for the same.
