12. Delivery Schedule :

Six (06) months from the date of final drawings/ docs. approval or manufacturing clearance, whichever is earlier. Drawings/documents shall be submitted within 2 weeks from the date of PO and every re-submission of drawing/docs. within 10 days from the date of BHEL/Customer comments incorporating all the comments. Delay, if any will be attributed to respective accounts.

13. Provenness Criteria : Bidder to note that the proven-ness criteria for Control Valves shall be as follows :

"Control valve offered for this package shall have at least one year's satisfactory operation prior to the date of Techno-Commercial.bid opening in one power station having unit rating of 200 MW or above.

The Bidder should have carried out Engineering of Control Valves of at least one (1) unit of a coal fired power station having unit rating 200 MW or above which is in successful operation for a period of not less than one (1) year prior to the date of Techno-Commercial Bid opening. In case the Bidder does not have the engineering experience of the complete plant as described above, then the Bidder shall get the Control valve of the remaining plant area (s) done through any of its sub vendor(s) / supplier(s) or through Engineering firm(s) who meets the above requirement for the respective plant area(s)."

14. Pre-Qualifying Requirements :

Bidders are requested to furnish the details as per "TECHNICAL, AND FINANCIAL PRE-QUALIFYING REQUIREMENTS" (attached with the enquiry document) and to submit the credentials for their approval.

Bids of only those bidders shall be evaluated who meet the Technical as well as Financial pre-qualifying requirements (if, applicable). Credentials of the bidders meeting the prequalifying requirements shall be taken up with customer for approval. Price Bid/RA of only BHEL and customer approved vendors shall be opened/done.

15. Bidder to note that this is a conditional enquiry (Open Global Tender) for those who are not registered with BHEL PEM and/or are not approved by customer for the subject project/package, the price bid (Part-II) opening/RA shall be subject to following criterion :

a) **Approval of bidder by the BHEL :** The bidders which are not registered with BHEL-PEM, refer Supplier Registration Form (SRF) attached with enquiry and submit the same duly filled (with signed & stamped) in along with credentials, experience list, performance certificates and other statutory data with their bids for vendor registration.

b) **Approval of bidder by Customer :** Approval shall be taken up by BHEL with customer based on the credentials/reference list. Hence Bidders are requested to submit the following (as part of their credentials) on or before technical bid Part-I opening :-

- i. Reference list indicating PO details, customer name, PO date, execution date etc.
- ii. Performance certificate issued by the clients.
- iii. Bidders are requested to fill up their details in NTPC format for Main & Sub – Supplier Questionnaire attached with enquiry) and submit all the supportive documents against details furnished therein.

16. **Indigenous bidders have to quote freight charges in percentage of their quoted Total Ex-works prices.**

17. BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'online sealed bid' in the Reverse Auction. Non-submission of 'online sealed bid' by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.

19. BHEL reserves the right to finalize Prices by conducting Reverse Auction or by conventional way of price bid opening, which will be decided after techno-commercial evaluation. In view of above, bidders are requested to quote their most competitive prices as **no negative price impact** shall be applicable on account of non-conduction of RA.
20. All the above Tender Documents shall automatically become a part of the Order/Contract after its finalisation.
21. Evaluation will be done on overall L1 (Total cost to BHEL i.e, F.O.R. Site Price) basis.
22. Indigenous bidders have to quote F.O.R. site prices and foreign bidders to quote their F.O.B. port price. However, F.O.R site prices for foreign bidders will be calculated by loading their F.O.B. port price as per GCC, Rev.06.
23. **All corrigenda, addenda, amendments, time extensions, clarifications etc, to the tender will be hosted on website only. Bidders are requested to visit constantly our websites to keep themselves updated.**
