14. Bidder to note that this is a conditional enquiry (Open Global Tender) for those who are not registered with BHEL PEM and/or are not approved by customer for the subject project/package, the price bid (Part-II) opening/RA shall be subject to following criterion :
- Approval of bidder by the BHEL :** The bidders which are not registered with BHEL-PEM, refer Supplier Registration Form (SRF) attached with enquiry and submit the same duly filled (with signed & stamped) in along with credentials, experience list, performance certificates and other statutory data with their bids for vendor registration.
  - Approval of bidder by Customer :** Approval shall be taken up by BHEL with customer based on the credentials/reference list. Hence Bidders are requested to submit the following (as part of their credentials) on or before technical bid Part-I opening :-
    - Reference list indicating PO details, customer name, PO date, execution date etc.
    - Performance certificate issued by the clients.
    - Bidders are requested to fill up their details in NTPC format for Main & Sub – Supplier Questionnaire attached with enquiry) and submit all the supportive documents against details furnished therein.
15. **Indigenous bidders have to quote freight charges in percentage of their quoted Total Ex-works prices.**
16. BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.  
In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'online sealed bid' in the Reverse Auction. Non-submission of 'online sealed bid' by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.
