2. Offers should be submitted in two parts in two separate sealed covers as follows:

3. Bidders shall submit their offers meeting the requirements of the following tender documents indicated in GCC, Rev. 06 and other Terms and Conditions included in this Enquiry Letter :

14. **Delivery Schedule :**

- a) For LOT 1:- Delivery shall be within Four (04) months from Drawing/Documents approval. This is subject to submission of drawing/documents (as mentioned in Annex. II of Vol. II B, Section C of technical specification) by vendor within 02 weeks of PO/LOI and vendor to re-submit documents within 10 days taking care of all comments. In case there are delays of submission of documents beyond 02 weeks of PO/LOI or 10 days of comments, that much days of delay would be reduced from the delivery period.
- b) Subsequent Lots: - A lead time of (02) months shall be given for completion of supply of each lot from the date of clearance of quantity. Date of PO amendment shall be considered as date of clearance.

15. **Pre-Qualifying Requirements :**

Bidders are requested to furnish the details as per "TECHNICAL AND FINANCIAL PRE-QUALIFYING REQUIREMENTS" (attached with the enquiry document) and to submit the credentials.

Bids of only those bidders shall be evaluated who meet the Technical as well as Financial pre-qualifying requirements (if, applicable). Credentials of the bidders meeting the prequalifying requirements shall be taken up with customer for approval. Price Bid/RA of only BHEL and customer approved vendors shall be opened/done.

- a) **Approval of bidder by the BHEL:** "Online Registration Portal is operational in BHEL. Non-registered Vendors, who wish to apply for registration with BHEL-PEM, have to apply through Online Registration Portal available at www.bhelpem.com → vendor section → Online Supplier Registration. All credentials and/or documents duly signed and stamped related to registration has to be uploaded on the website and submit the application for registration. One set of hard copy of the filled-up SRF downloaded from Online Registration Portal duly signed and stamped has to be submitted.
- b) **Approval of bidder by Customer:** Approval shall be taken up by BHEL with customer based on the credentials/reference list. Hence Bidders are requested to submit the following (as part of their credentials) on or before technical bid Part-I opening :-
- i. Bidders are requested to fill up their details in NTPC format for Main & Sub – Supplier Questionnaire attached with enquiry) and submit all the supportive documents against details furnished therein.
 - ii Reference list indicating PO details, customer name, PO date, execution date etc.
 - ii. Performance certificate issued by the clients.
17. **Bidders have to quote freight charges in percentage of their quoted Total Ex- works prices.**
18. Bidders to note that No CIF Content is available for this package.
19. All the above Tender Documents shall automatically become a part of the Order/Contract after its finalisation.
20. Evaluation will be done on overall L1 (Total cost to BHEL i.e., F.O.R. Site Price) basis.
21. The total quantity variation shall be limited from -30 % to +30% of the total contract value derived on the basis of the order quantities.
