necessarily submit online sealed bid in the Reverse Auction. Non-submission of online sealed bid by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.

Terms and Conditions of Reverse Auction shall be as per enclosed annexure-I.

6. PVC clause shall be applicable as per enclosed PVC Annexure.

7. **Delivery Schedule:**

The quantities will be released for manufacture in more than one lot. Lot-I quantities shall be released for manufacture along with PO/LOI. Manufacturing of Lot-I quantities shall be done after the approval of technical and quality documentation, and supply of same shall be completed within four months of date of approval of documents. Subsequent lots shall be cleared for manufacture based on progress of engineering and site requirements. A lead-time of three months shall be given for completion of supply of each lot from the date of clearance of the quantities.

Drawing Document Submission Schedule: First submission of drg. /docs shall be done in 15 days of PO and every resubmission, if required, within 07 days of receipt of comments incorporating all BHEL comments. BHEL will approve/comment on the drg./docs. within 07 days from the date of submission/resubmission. In case there are delays in submission/resubmission of documents by vendor beyond indicated schedule, that much days would be reduced from delivery period. Similarly, any delay in approval/comment by BHEL beyond indicated schedule shall be added to the delivery period.

8. Bidders have to note that Deviations from NIT are generally not acceptable. Deviations, if any, are to be listed out clearly, as per Annexure-II, of GCC Rev 06, in techno-commercial offer. Any deviation mentioned or shown separately or found hidden in offer, will not be taken cognizance of.

In case of deviations from NIT, the bidder shall give the cost of withdrawal of such deviation in Sealed Cover as per Annexure-II, Deviation Sheet (Cost of Withdrawal), as per GCC Rev-06.

9. Bidders have to note that this is a conditional Open Tender enquiry. Price bid (Part-II) opening/RA participation of those bidders, who are not approved by (end) Customer, shall be subjected to approval of bidder by the (end) customer and Techno-commercial recommendation by BHEL. Approval shall be taken up by BHEL with customer based on the credentials/reference list. 
