TERMS AND CONDITIONS (In conjunction with Tender Enquiry Letter terms) :

1. Pre-Qualifying Requirements:

Bidders have to provide the required details as per "TECHNICAL AND FINANCIAL PRE-QUALIFYING REQUIREMENTS" (enclosed as NIT Tender Documents). Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.

2. Bidders have to note that this is a conditional Open Tender enquiry. Price bid (Part-II) opening/RA participation of those bidders, who are not registered with BHEL PEM / not approved by Customer (NLC), shall be subjected to following criterion:

a. Approval of bidder by the BHEL

The bidders (who are not registered with BHEL-PEM) has to download the Supplier Registration Form (SRF) from www.bhel.com / [http:// www. bhelpem.com/ Vendor%20Corner.aspx](http://www.bhelpem.com/Vendor%20Corner.aspx) and submit the same duly filled in along with credentials-experience list, performance certificates and other statutory data to our Vendor Development section with intimation to us.

b. Approval of bidder by Customer

Same shall be taken up by BHEL with the customer based on the credentials/reference list being submitted by the bidder. Bidders to note that following has to be the part of their credentials:-

- Documentary evidence to show that similar or higher capacity component/equipment/system has been supplied by the vendor or their associate/collaborator. The documentary evidence shall be in the form of Material Receipt Certificate, Site Inspection Report, etc from the end user for having received the material by the end user.

3. Bidders have to note that TERMS AND CONDITIONS of the tender shall be as per General Conditions of Contracts (GCC, Rev. 06), Special Conditions of Contract (Rev 00) and as per these Notice Inviting Tender (NIT) conditions. 
