

18. Any other taxes & Duties applicable on the date of bid but not quoted by the bidders shall be to bidder account.

19. Indian Bidders have to quote freight charges in percentage of their quoted Total Ex-works prices.

20. Foreign bidders will have to quote C & F (cost & freight) basis instead of FOB.

For importing materials on C&F basis, bidders to note following:

a. As per Incoterms (CFR), risk transfers to buyer when the goods have been loaded on board the ship in the country of Export. Hence, shipped on board date mentioned on the clean Bill of Lading or Air way Bill, shall be treated as the date of Shipment/ Dispatch for all contractual purposes including calculation of LD.

b. Usance period (90 days) of the L/C shall start from the date of Bill of lading/Air Way Bill.
