Annexure-1 Technical –Cum-Commercial Bid

Scope of work:

1. The scope of work involves commuting employees safely and in time from various parts of Bangalore to BHEL-ESD Factory at Electronics City, Hosur Road in the morning & in the evening from factory to their respective pick-up points including other fixed trips apart from assigned trips on need-basis from time to time.
2. This tender is valid for a period of TWO (2) years effective from 01.04.2015 to 31.03.2017. The successful bidder on whom the work order will be placed is termed as “contractor” in this document.
3. The number and type of vehicles to be provided is as follows:

Sl.no	Vehicle type	Qty
1	12+1 Seater (TT's/Force traveler) of 2013 Model or Later	6 nos.

4. BHEL – ESD reserves the right of changing the routes of the various vehicles. **ONE** TT/Force traveler with the Driver will be retained at ESD for official use for local trips after the morning trip to factory within the daily working time of BHEL-ESD. Other vehicles will leave the premises and report back at 3.30 PM for the evening trip. Choice of which vehicles to be retained at ESD will be the discretion of BHEL ESD. Without authorized permission of BHEL-ESD HR, the designated vehicle should not leave ESD premises.
5. The vehicles provided must be of 2013 model or later.
6. Bidders must directly own all the Six (6) vehicles of 12+1 seater. Proof of direct ownership (as per Cl.18 of Technical Bid) must be enclosed along with the bid.

Annexure-1 - Terms & conditions

- 1 All vehicles are required to report at the designated place of first pick-up point of all routes 15 minutes before the commencement time. The commencement time and the pick up point of each route is given in Annexure.
- 2 The present factory timings are from 07.30 hrs to 16.36 hrs (Monday to Friday) and 0730 hrs to 1230 hrs (Saturday). The vehicle should arrive at BHEL ESD front gate at 7.25 AM in the morning and should leave BHEL ESD Gate at 16.40 hours in the evening. In case of any change in timings, the same will be informed to the vendor within ten days' notice.
- 3 Bidder should have successfully completed similar works during the last seven (7) years as per details hereunder (Copy of work order and completion certificate to be enclosed along with bid. In case of ongoing contracts, the works order and performance certificates are to be provided):-
 - a) Three (3) completed contract works of providing TT/Force travelers on hire basis costing not less than the amount equal to 40 % of estimated cost ie.38 Lakhs (OR)
 - b) Two (2) completed contract works of providing TT/Force travelers on hire basis costing not less than the amount equal to 50 % of estimated cost ie.48 Lakhs (OR)
 - c) One (1) completed contract work of providing TT/Force travelers on hire basis costing not less than the amount equal to 80 % of estimated cost ie.77 Lakhs

If any bidder is not fulfilling any of above conditions from a to c will be summarily rejected.

- 4 The valid records/documents like RC Book, Vehicle permit, Insurance, Driving License's of Drivers, Emission certificate etc., should be produced at the time of award of contract and whenever required by us for verification. Vehicle should be in good running condition of 2013 model or later & all statutory requirements of RTO/Police, etc., should be fully complied with.
- 5 The Bidder shall be responsible for providing vehicle Drivers with License. The drivers must possess valid driving license and have at least five years' experience driving similar vehicles. The drivers' license document is to be produced for verification by BHEL, whenever demanded.
- 6 The rate quoted should include the charges towards fuel, wages, permit, insurance, taxes (including Service Tax) and maintenance of vehicle, statutory payments etc., and the rate shall be subjected to price variation clause on increase/decrease of fuel prices during the contractual period.
- 7 Contractor will also be responsible for their courteous behavior towards the BHEL Staff, Executives, customers and passengers in the vehicles. Drivers will strictly adhere to instruction and directions issued by BHEL when the vehicles are on duty and at our command. Strict discipline shall be ensured by contractor. The contractor shall be responsible for behavior of his driver at company premises.

Annexure-1 - Terms & conditions (Contd)

- 8 ONE vehicle to be retained for BHEL premises for use. BHEL - ESD reserves the right to use the vehicle at its discretion. In case the same vehicle is required by the Contractor, it will be released only against arrival of the suitable alternate [good running condition] vehicle at our premises irrespective of the reasons.
- 9 Trip sheet should be maintained properly by recording time, kilometres on daily basis and obtain the signature from the first pick-up/last drop-employee on same day.
- 10 The names of the successful bidder's staff/representatives along with their office address/contact numbers have to be furnished by the contractor who have to be contacted, during exigencies or for necessary clarification.
- 11 The vehicles in this tender are for carrying adults. Vehicles of the same seating capacity used as school vehicles with lesser leg space are not acceptable. Short roof vehicles are not allowed.
- 12 BHEL - ESD reserves the right to terminate the contract with one month's notice if the performance is not satisfactory.
- 13 Bidder shall be responsible for covering contractor's/ drivers'/supervisors against all statutory regulations including personal accident insurance etc. BHEL-ESD shall not be responsible for any consequences arising on account of any violation of any statutory provisions, rules/regulations by the Bidder.
- 14 In case of any breakdown of running vehicle, alternate arrangement of same seating capacity and in good running condition should be made within half-an-hour to fulfill the contractual terms. Failure to make alternate arrangement will result in levying of appropriate penalty as given below.
- 15 After dropping the employees/morning trip, Drivers/Supervisors of the Contractor will not be allowed entry inside the factory.
- 16 The drivers of the TT/Force traveler should be wearing Uniform during driving for BHEL, as per RTO guidelines.

Submission of bid:

Bidders shall submit their bids in two parts in sealed in two separate covers super scribed "Annexure – 1" and Annexure - 2" respectively (empty formats given below) with tender reference no. and date.

While submitting, both Annexure 1 and Annexure 2 should be enclosed in separate cover addressed to AGM/HR & FS, ESD, BHEL, Bangalore and dropped in Tender box at the employer's location or couriered to AGM/HR & FS in the above address. All the pages of the documents submitted to BHEL should be duly signed by the Contractor.

17 EMD: Every tender must be accompanied by Demand Draft drawn in favour of BHEL-EDN for 1.5 Lakhs as Earnest Money Deposit. This earnest money will be refunded to the unsuccessful bidders after finalization of the award of work without any interest. In the case of the successful bidder(contractor), the earnest money will be retained as part of the Security Deposit for satisfactory completion of the work in accordance with Clause – 19(viii) of the BHEL General Conditions of the Contract. Tenders without Earnest Money Deposit receipts are liable to be rejected. No interest will be paid on the earnest money deposits. **It may be noted that Techno-commercial bid without EMD will be summarily rejected.**

Payment:

- 19 Trip Sheets should be maintained by the Drivers reflecting journey undertaken daily which will invariably be get filled-up by driver affixing his signature and the same duly certified by the authorized official deputed for this work. The Trip sheet Book will be provided by BHEL-ESD and the same has to be submitted on monthly basis (calendar month) along with the bills. Payment will be made on or within Thirty (30) days from the date of submitting the bill.
- 20 Payment will be made only once in a month. Bidder will submit the bills on monthly basis(Calendar month), which will be duly verified, checked and passed by ESD HR department and forwarded to Finance Department of BHEL – EDN Bangalore for releasing payment to the contractor.
- 21 If any discrepancies in the trip sheets/bill will be returned immediately for re-submission after correction by the contractor within 1 month. All payments will be made by Electronic Fund Transfer (EFT) for which bidders shall fill in the EFT format giving their Bank A/c details. EFT will take place within thirty (30) days of submission of clear bills. Electronic fund transfer form is enclosed herewith.

Penalties applicable:

22 Failure to meet the contractual requirements will result on levying of **Penalty** as below:

i) If the vehicle has not reported at first Pick – Up point [Breakdown while reaching the first point from garage] but reaches the factory late after repair/ substitution of vehicle	50% of the daily rate
ii) If the vehicle is not available at our disposal for half-a-day and less i.e. half of the specified slab hours and less [tolerance of 15 minutes allowed]	75% of the daily rate
