WORK SPECIFICATION

1. SCOPE OF WORK OF THE CONTRACTOR SHALL BE AS FOLLOWING:

- a. The contractor shall be responsible for “In House Fabrication & Testing of Power Transformer Tanks and/ or Power transformer accessories (Header, Conservator, pipe work & its matching, supports & brackets, cooling Fans, Ladder, Thermosyphon assy. Etc.) in BHEL Jhansi”. While a representative drawing no. 14620050226 is enclosed for reference, the contractor shall execute the job as per the drawing provided by the Fabrication Deptt., BHEL, Jhansi.
- b. The scope of work also includes material preparation (cutting, bending, rolling, drilling, dressing etc. which includes steel blanks for machining), assembly (fitting, welding, testing, shot blasting, NDT testing), painting and getting the jobs cleared by QC (BHEL) / Customer as per BHEL Quality Plan.
- c. Only material, electricity, compressed air, cutting gases, tools, consumables, like electrodes, grinding wheels & discs etc, available with BHEL shall be provided by BHEL free of cost. In stages machining operation shall be in BHEL's scope. Machines/equipments such as welding machines, grinding machines etc. shall be arranged by vendor.
- d. EOT crane shall be provided by BHEL free of cost; however, assistance in operation of the same shall be the responsibility of contractor. In contingency, in order to meet the job requirement, any additional resources if required shall be arranged by the contractor at their cost.
- e. Inspection at various stages shall be done by BHEL-QC / Customer and proper record shall be maintained by vendor. Inspection/clearance by BHEL-QC / Customer shall be the responsibility of the contractor. In addition, the Contractor shall attend to any rework/ modifications, as and when suggested by BHEL-QC / BHEL Engg/ Customer.
- f. The Contractor shall be responsible for complying with all the applicable statutory acts & laws.
- g. Contractor may be required to work in 3 –shifts. Contractor shall appoint supervisors (minimum diploma) for A/B/C Shifts for coordination with various departments of BHEL, Jhansi. Contractor has to organize adequate work force of qualified and experienced welders and fitters to take up parallel working for fabrication. **For this the contractor shall arrange labour license of required number of workers from govt. before start of contract.**
- h. Contractor shall give undertaking for providing skilled & Un-skilled manpower as per requirement of BHEL during execution of contract.

2. MEASUREMENT OF WORK & PAYMENT:

- a. Work shall be measured in terms of Kilogram and payment made on as per weight given in respective drawing(s). 4. **Delivery Period:** One week advance notice/ letter of intent (LOI) shall be given to the Contractor(s) for starting the work. Delivery requirement for the execution of work will be intimated in notice/ LOI at the time of loading work on contractor.
5. **LD Clause:** For late completion of work, BHEL standard LD clause shall be applicable which is 0.5% per week or part thereof, subject to maximum 10% of contract value.
6. **Reverse Auction:** BHEL reserves the right to conduct Reverse Auction (RA). The bidder shall give an undertaking conveying their agreement to participate in RA. Annexure K is to be referred for terms and conditions of RA.
7. **Termination of contract:** Based on the time to time performance of the contractor, if the same is under par than that required by BHEL, Then BHEL will have the right to terminate the contract after giving due information of the same to the contractor at least 2 weeks in advance.

CONTRACTOR'S OBLIGATIONS

A) Towards selection, control and supervision of employees

- a) **Contractor shall decide the number of employees to be deployed** for execution of the work awarded to him and he or his authorized representative will be solely entitled to instruct such workers about the manner of carrying out the work as per the prescribed specifications and quality plan.
- b) Contractor **shall supervise the work** allotted to him and to be carried out by his employees.
- c) **Age of workers: The contractor shall not employ any person who has not completed his 18 years. Also age of worker deployed should not exceed 60 years.**
- d) Contractor to ensure that the employees deployed in the premises of BHEL **are physically and mentally fit and do not have any criminal record.** Such employees should **possess requisite skill, proficiency, qualification, experience etc.)**
- e) Contractor to **maintain appropriate records of his employees** deployed to carry out the job(s). Contractor shall maintain neatly written, complete and legible registers, records, reports and returns for inspection by various authorities at short notice.
- f) Contractor will ensure that the **job is executed through his employees** on his rolls and under no circumstances the contractor will deploy any casual employee to carry out the job **nor shall sub-contract the job without prior written permission.**
- g) **Discipline:** The Contractor shall be responsible for the discipline of his own employees deployed under the contract. In case of any loss to the BHEL Jhansi on account of indiscipline of employee then such loss shall be assessed and recovered from the running bills of the contractor or from the security deposit.
- h) The contractor, on advice of authorized BHEL official, shall immediately remove any person employed by him, who may in the opinion of such authorized BHEL official is involved in misconduct. Such person shall not be re-employed by the contractor without prior permission.

- i) Contractor **will keep watch on his employees and he will be liable for any pilferage / loss to BHEL** due to acts of omission and commission by his employees. In case any worker leaves the job or fresh worker is deployed then also providing helmets, shoes, tools and tackles, accident insurance etc. to the fresh worker shall be in contractor scope and no extra amount shall be payable to this account by BHEL.

- l) In the event of termination of contract for any reason whatsoever, the **contractor shall withdraw all his employees** from the establishment of BHEL. The last payment shall be released only after the Contractor has surrendered all passes to BHEL. In case it is found that the workers of the Contractor are inside the premises of BHEL with an invalid permit, the Contractor is liable for penal action. In case contractor decides to terminate services of his employees, he **should settle all terminal dues required.**
- m) Contractor shall provide to **his employees all tools, tackles, material, equipments as specified in contract** and maintain the same to carry out the job under the contract at his cost and if necessary may take insurance policy of his worker, material, equipments & tools & tackles.

B) Towards statutory liability

No separate reimbursement shall be made by BHEL to this account. Payment shall be made as per rates quoted by the contractor.
