1.2 Techno - Commercial Bid

1.2.1 Techno Commercial Bid consists of the following documents and the same shall be duly signed & stamped by the bidder in all the pages and submitted in full in token of the acceptance of the same.

1.2.3 All the required documents shall be filed in the same serial as per the format/column of the "Techno Commercial Bid". **All the pages shall be serially numbered on the right hand side top corner.**

1.2.5 Offers without relevant documents are liable to be rejected.

2 TENDER DUE DATE

2.1 Last date/time for receipt of tender

- 2.1.1 The completed tenders shall reach on or before **10:30 Hrs. on 05.02.2015**. It is in their own interest to ensure that the tenders reach in time. BHEL is not responsible for any postal delay. Tenders not submitted in the prescribed forms or incomplete tenders are liable to be rejected.

2.2 Last date/time for opening of tender

- 2.2.1 Sealed covers so received will be opened at Bldg. No.61, 1st Floor, Stores Admin Block. (Near East Gate) , in BHEL, Tiruchirapalli on the same day i.e., on **05.02.2015 at 10:35 Hrs.** in the presence of the Bidders or their Authorised Representatives who may choose to witness the same.
- 2.2.2 The Techno Commercial bids only will be opened

2.3 Witnessing the tender opening

- 2.3.1 The representative of the Bidder may choose to witness the tender opening have to produce the Authorization Letter, as per the **enclosed proforma**, before opening of the tender. The representatives without Authorization Letter in the prescribed format will not be allowed to participate in the tender. Only one representative from one bidder will be allowed to participate in the tender opening.

2.4 Pre-Bid Meeting

- 2.4.1 If the bidders are expressing their interest for Pre-Bid meeting, separately through email, Pre-Bid meeting will be conducted on **22.02.2014 at 10:00Hrs.** at the CCC/Logistics, BHEL Trichy.

3 QUOTING

3.1 Option

- 3.1.1 **The Bidder may choose to quote for any one or both the Categories i.e. Category-A – Southern States and/or Category-B – Non-Southern States.**

- 3.1.2 Each Category has 3 Applications and each application has 4 Rate schedules

3.2 Quoting best rate and the sanctity of the L1 status.

- 3.2.1 Quoting the lowest best rate is a must against this Tender. However, transporters are required to understand that the lowest rate offered by them or accepted by them, as the case may be, should be honoured throughout the tenure of the Contract. During the tenure of the Contract, if any such Transporter who have quoted/accepted the lowest rate, do not place the vehicle on whatsoever may be the reason, will be considered as a defaulter and that will purport to sabotaging the total tendering process of BHEL. Hence BHEL reserves right to take severe action under Contractual obligations including legal action against those Transporters

3.3 Participation

- 3.3.1 Transporters who have been suspended or black listed by any other BHEL unit will not be allowed to participate in the tender and the bidder should declare the same in the tender. Even during the course of evaluation / finalization of tender if it is found that some of the transporters are black listed / barred from business transactions / under business holiday, BHEL will not consider them for further participation in the tender.

4 VALIDITY OF OFFERS :

The rates quoted shall be valid for acceptance for a minimum period of 90 days from the date of Price Bid opening. Withdrawal of Tender or increasing the rates during this validity period, leads suitable action a per BHEL procedure.

5 METHOD OF EVALUATION OF PRICES

5.1 Ranking

5.1.1 Individual Rate Schedule wise ranking of Bidders will be done.

5.1.2 In case of tie in the rates quoted by the bidder, the ranking will be decided based on lot system, in presence of the bidders who witness the price bid opening.

6 QUANTITY, RATE FINALIZATION & DISTRIBUTION OF LOAD

6.1 Tender quantity & Notional Contract Value

6.1.1 Since this is a rate Contract, there is no fixed tender quantity.

6.1.2 However the notional Contract value of ₹50/- Lakhs for a period of Two years is arrived at for Non-Southern State Operations and ₹15/- Lakhs for a period of Two years is arrived at for Southern State Operations

6.1.3 BHEL will split the notional value among 4 (two) Bidders for each Category and place Contracts accordingly. The L1 Bidder will be given more number of opportunity (two demands in each demand cycle whereas the other bidders get one demand) to lift the load.

6.2 Rate Finalization

6.2.1 BHEL will finalize the rates through paper price bid opening. Hence tenderers are requested to give their best prices at the first instant itself.

6.2.2 Lowest prices received against BHEL tenders need not be the acceptable to BHEL and in that case BHEL will not consider the same for award of Contract.

6.2.3 BHEL would negotiate or refloat the tender opened if L1 price is not the lowest acceptable price to them inter-alia other reasons.

6.3 Load Distribution

6.3.1 The L1 Bidder will be allotted 2 loads in each demand turn while the other bidders get one demand in each turn.

6.3.2 Initially the demand will be allotted to a Carrier as per loading seniority, if the original allotted is not placing vehicle, within the stipulated time (i.e. 24 Hrs. for placement of vehicles at BHEL Trichy, 48Hrs. for Placement of vehicles at Chennai Harbour / Airport and 72 Hrs. for placement of vehicles to other areas other than BHEL Trichy & Chennai Harbour / Airport), then same demand will be displayed as "Open Demand" to the Carrier including the original allottee and load will be allotted on first come first served basis. Notice time will be reckoned from morning 10:00 am onwards.

6.3.3 BHEL also would load on first- come- first- served basis, in case of non response from L1 Bidders within the time frame given to meet the transportation requirement of BHEL.

6.4 Counter Offer

- 6.4.1 BHEL would counter the L1 rates / negotiated and accepted L1 Rates to other Carriers in the order of their ranking till another three Carrier accepts Counter offer for award of Contract for each rate schedule (**Totally 4 carriers are envisaged for each rate schedule for award of Contract**).
- 6.4.2 Individual rate schedule wise, counter offer will be given.
- 6.4.3 The may free to accept the given counter offer for any number rate schedules.

7 GENERAL INSTRUCTION

7.1 Quoting & signing the tender

- 7.1.1 While quoting their rates, the Bidders are advised to take into account the likely expenditure, taxes what so ever, etc., excluding Service Tax & Octroi, in deploying the vehicles during the operation of Transport Contract for two years from the date of award of Contract.
- 7.1.2 The rates quoted in the schedules are applicable for the distances involved from the place of booking to the destination.
- 7.1.3 All entries in tender documents shall be clearly written in one ink or typed. All the corrections/cancellations/ insertions, if any, shall be duly attested by the Bidders concerned.
- 7.1.4 Rates should be quoted as per the Price Bid. Rates quoted in any other form will not be accepted and will be rejected.
- 7.1.5 The rates shall be quoted only in the schedule attached, both in words and figures. Wherever there is a difference between the words and figures, amounts indicated in words only shall be considered as correct.
- 7.1.6 The Bidder shall fill in all the required particulars of the Tender documents and also sign on each and every page of the Tender documents (Techno- Commercial Bid, Price Bids, Terms & Conditions etc) before submitting their tenders.
- 7.1.7 In case the Bidder is a Partnership Firm under Partnership Act, the tender shall be signed by all the Partners of the firm or by the Managing Partner who have authorized to do so or by a person holding the Power of Attorney on behalf of the Partnership Firm.
- 7.1.8 Should a Bidder find discrepancies or omissions in the tender documents or should there any doubt as to their meaning, he should at once address the authority inviting the tender, for clarification well before the due date, so as to submit his tender in time. (No extension of time shall be given for submission of the tender on any account)
- 7.1.9 Conditional and late tenders, tenders containing prima-facie absurd rates and amounts, tenders which are incomplete or otherwise considered defective and tenders not in accordance with the tender conditions herein contained and the tenders not in original **ARE LIABLE TO BE REJECTED**
- 7.1.10 If a Bidder deliberately gives wrong information in his tender or creates conditions favourable for the acceptance of his tender, **BHEL WILL REJECT SUCH TENDER AT ANY STAGE.**

1 SCOPE OF WORK

1.1 Category-A

Collection, storage, transportation and safe delivery of materials on Speed Cargo Movement Basis. Scope covers **both Collection & Delivery of materials within Southern States of India** namely Tamil Nadu, Pondicherry, Andhra Pradesh, Kerala & Karnataka & Telengana.

1.2 Category-B

Collection, storage, transportation and safe delivery of materials on Speed Cargo Movement Basis. Scope covers **either Collection or Delivery of materials in any state other than Southern States of India**

2 TENURE OF CONTRACT

2.1 Tenure

- 2.1.1 The transport Contract is valid for **2 (two) Years** from the date of LOI issued by BHEL, Trichy
- 2.1.2 The consignments, including self consignments booked within the Contract period fall within the scope of the Contract, irrespective of the date of delivery and surrendering of the consignee copies of the LR / GRs.

2.2 Extension of Contract

- 2.2.1 One or more extensions of the Contract may be done with mutual agreement between BHEL, Trichy and the approved transporters, subject to a maximum extension period of 12 months. Such agreements shall be based on acceptance of the lowest rates and terms & conditions of the corresponding Contract

3 LOADING AND UNLOADING

- 3.1.1 Loading and unloading is the responsibility of consignor or consignee at BHEL / Vendors / Sub-Contractors/ Sites will be taken care of by the respective Agency
- 3.1.2 Normally no handling or transshipment is permitted enroute. However, loading and unloading at other intermediate places due to transshipment will be the responsibility of the Carriers and no claim on this account will be entertained by BHEL.

4 COLLECTION & DELIVERY:

- 4.1.1 It is the responsibility of the Contractor to collect and deliver the consignment safely to the consignee within the committed delivery/transit time.

5 RATE

The Rates to be finalized are firm except for rate variation on account of variation in Diesel Price as given below:

- 5.1.1 Increase / decrease of **3 Paisa per kg** for the increase / decrease of **every one Rupee** in the Retail Selling Price (RSP) of diesel as indicated by IOCL / BPCL / HPCL in their website. For this purpose the diesel rate prevailing at State Capital i.e. at Chennai will be considered.
- 5.1.2 Less than ₹ 1/- increase / decrease will not be considered for revising the Contract rates. However the cumulative variation in, equal to or more than ₹ 1/- will be considered for revising the Contract Rates from the date of cumulative increase/decrease of Diesel.
- 5.1.3 PVC will be operative only from the date of award of LOI

5.2 Sample Calculation:-

Assume existing RSP of HSD at Chennai is **Rs.57.26/- per Liter** on the date of LOI i.e. on 01.03.2015.

- 5.2.1 Effective from 15.03.2015, if the diesel price increases from Rs.57.26/- to Rs.57.80/- per Liter i.e. increase of Rs.0.54 per Liter, then PVC will not be applicable from 15.03.2014
- 5.2.2 Again effective from 01.04.2015, if the diesel price increases from Rs.57.80/- to Rs.58.36/- per Liter i.e. increase of Rs.0.56 per Liter.
- 5.2.3 In this case the cumulative increase is Rs.1.10/- per Liter (Rs.0.54 + Rs.0.56). Then PVC is applicable from 01.04.2015 onwards only for the increase of Rs.1.10/- per Liter.
- 5.2.4 For example if the freight rate is Rs.6/- per kg. it becomes Rs.6.03/- per kg. ($6 + (1.10 * 3/100)$)
- 5.2.5 Again effective from 15.04.2015, if the diesel price increases from Rs.58.36/- to Rs.58.89/- per Liter i.e. increase of Rs.0.53 per Liter, then PVC will not be applicable from 15.04.2015
- 5.2.6 Again effective from 01.05.2015, if the diesel price increases from Rs.58.89/- to Rs.59.49/- per Liter i.e. increase of Rs.0.60 per Liter.
- 5.2.7 In this case the cumulative increase is Rs.1.13/- per Liter (Rs.0.53 + Rs.0.60). Then PVC is applicable from 01.05.2015 onwards only for the increase of Rs.1.13/- per Liter.
- 5.2.8 The same system will be followed for decrease in Diesel Prices also.
- 5.2.9 Only two digits fraction will be considered. i.e. in the revised rates anything less than 0.005 Paisa will be ignored and anything equal to or greater than 0.005 will be rounded off to 0.01 Paisa

5.3 TAXES AND DUTIES

- 1.1.1 While quoting their rates, the Bidders are advised to take into account the likely expenditure, taxes what so ever, etc., excluding Service Tax & Octroi.
- 5.3.1 The quoted rates shall be inclusive of all charges such as Surcharge, Hamali, Statutory charges, Goods Tax, Loading and Unloading enroute etc., except Service Tax & Octroi, and no extra claim whatsoever shall arise on any account over and above the accepted rates during the currency of Contract will be entertained.

5.4 OCTROI CHARGES:-

- 5.4.1 Octroi charges, wherever payable, have to be paid initially by the Contractor, which shall be reimbursed on submission of Documentary proof identifying BHEL consignments for the payment thus made.
- 5.4.2 Octroi Duty if any to be paid by the Carriers on behalf of BHEL will be reimbursed by BHEL on production of the Cash Receipt duly identifying BHEL Consignments by BHEL on production of the Cash Receipt duly identifying BHEL Consignments or they have to coordinate with our Agent en route near check post for effecting the Octroi payment with relevant documentation. The name, and phone no. of the contact person and address have to be collected at the time of booking the consignment and all documentation (such as road permit, sale in transit etc.) shall be complete before leaving the loading premises. Any laps and latches will be the account of transporter for payment of Octroi where ever applicable.
- 5.4.3 In the cases where Octroi is paid by the carrier/consignee/consignor, 3 days grace period shall be given extra against documentary evidence.

6 TRANSIT TIME & PENALTY FOR DELAYED DELIVERY:

- 6.1.1 The actual transit Time (number of days) for transit shall be calculated at the rate of 300kms per Day for end to end transportation (i.e. from loading point/godown to unloading point direct without change of vehicle)
- 6.1.2 Actual Transit Time + 1 Day for Booking + 1 Day for Delivery shall be allowed for the transportation without penalty Charges. In case of delivery of cargo to a destination where there is no branch office available (ODA), 3 days grace time is allowed.
- 6.1.3 In the cases where Octroi is paid by the carrier/consignee/consignor, 3 days grace period shall be given extra against documentary evidence.
- 6.1.4 In addition to the above one day grace period for distance up to 750 km. and two days grace period for distance more than 750 km. will be given
- 6.1.5 Anything more than the above time will be counted as DELAY and attract the penalty @ **1% of freight value per day.**
- 6.1.6 The above % of penalty is imposed on the TOTAL FREIGHT CHARGES of the consignment EXCLUDING OCTROI AND SERVICE CHARGES.
- 6.1.7 If the due delivery date happens to be a National Holiday, Public Holiday or Company Holiday, the delivery should be effected on the immediate NEXT Working Day.
- 6.1.8 No penalty will be levied for the following cases, against documentary proof, where the facts are beyond the control of Transporters
- (a) Delay in submission of Road Permit and other dispatch documents by BHEL.
 - (b) Site not accepting the delivery on the material arrival date.
 - (c) Delay in unloading the materials at site / consignee.
 - (d) Accidents enroute.
 - (e) Flood, local holidays, strikes, road blocks, bridge damages, force majeure etc., which are beyond the control of Transporters
 - (f) Other unforeseen circumstances.

6.2 SANCTION OF ADDITIONAL TRANSIT TIME

In case of exceptional situations indicated below, where the Competent Authority of BHEL, as per procedure shall, sanction the additional transit time on „case-to-case“ basis, based on the representation received from the Transporter, providing the full details / data/ reasons for the delay. BHEL on review of these details and upon verifying the proof for the reasons explained by Carrier, which is beyond his purview, may consider such additional transit time.

- 6.2.1 Delay in submission of Road Permit and other dispatch documents by BHEL.
- 6.2.2 Site not accepting the delivery on the material arrival date.
- 6.2.3 Delay in unloading the materials at site / consignee.
- 6.2.4 Accidents enroute.
- 6.2.5 Flood, local holidays, strikes, road blocks, bridge damages, etc., which are beyond the control of Transporters
- 6.2.6 Other unforeseen circumstances.

7 DETENTION CHARGES AT LOADING / UNLOADING POINTS.

Detention charges shall be paid extra if the vehicles are not loaded / unloaded in time.

- Date of reporting of vehicle at loading point and the date of release of vehicle with load at loading point security gate will be excluded for payment of detention charges at loading point.
- Date of reporting of vehicle at unloading point with load and the date of release of vehicle at unloading point security gate after unloading will be excluded for payment of detention charges at unloading point.

7.1 Detention Charges

- 7.1.1 In the loading point, if the vehicle is not loaded and released on the same day of vehicle reporting (excluding Sunday and Holidays), detention charges will be paid @ **₹ 500/- per Day**.
- 7.1.2 In the unloading point, if the vehicle is not unloaded and released on the next day of vehicle reporting (excluding Sunday and Holidays), detention charges will be paid @ **₹ 500/- per Day**.
- 7.1.3 For the above two cases, the vehicle has to report before 10.00 a.m. If vehicle reported after 10.00 a.m. then the date of reporting will be considered as next day 10.00 a.m. for detention charges purposes.
- 7.1.4 Detention charges will be restricted to maximum for 30 days including detention at loading & unloading point.
- 7.1.5 Detention charges shall be paid on certification of an Executive not below the rank of DGM of user agencies (Shipping / Commercial / MM etc.) in case of detention at BHEL, Trichy and Harbours / CFSs.
- 7.1.6 Detention at Site shall be paid based on the Gate Entry at Site / Any site personnel - with signature & official seal. In case official seal is not provided by the certifying person at site / if further clarity and confirmation required, the certification by DGM of Commercial / end user is required for payment of detention charges.
- 7.1.7 It is the responsibility of the Transport Carrier to obtain the required gate entries / endorsements in the G.C. with time & date from other areas such as Shipping / Stores / Harbour & CFS and Sites etc., to enable BHEL to effect the detention payment. Without this detention payment cannot be paid.

8 DOCUMENTATION:

- 8.1.1 It is the responsibility of the Contractor to collect all the required despatch documents such as Invoice, Sales Tax Forms, Bills, Excise Invoice, Packing List, Delivery chellans, Road Permit etc., from the consignor at the time of booking the consignments.
- 8.1.2 For the inward consignments, at the time of reporting to BHEL Security Gates, the Carrier should produce the relevant Challans, Packing Lists, Gate Pass etc, to make entry in the Gates.
- 8.1.3 Like-wise for the outward consignments, while collecting the materials from BHEL Complex to other Destination Points, the carrier should collect relevant Gate Pass, Packing Lists, Invoice etc. for taking out the material.
- 8.1.4 While accepting the consignments for transportation, the Carriers should doubly ensure, that necessary documents for check post are collected, so that the consignments are not detained en route for want of documents.
- 8.1.5 Any detention of consignment on this account will be the Carriers' responsibility.
- 8.1.6 If a consignment is detained en route by the check-post authorities and penalty, such as advance tax, compound tax etc. is imposed, such penalty will have to be borne by the Carriers. It is also the responsibility of the carrier to get the consignment released from the check post and deliver it in time.
- 8.1.7 The formalities of Excise duty gate Pass for the materials moved shall be adhered to strictly. The duplicate Transporter's copy of Excise Invoice etc., should be carefully brought and handed over to the consignee along with the materials. Any loss arising out of the failure to comply with the above shall be borne by the Carrier.
- 8.1.8 The Road Permit collected from the consignor should be handed over to the Consignee without fail.

9 FORCE MAJEURE :

- 9.1.1 If, at any time during the continuance of this contract the performance, in whole or in part, by either party of any obligations under this contract shall be prevented or delayed by reasons of any WAR, HOSTILE ACTS of the PUBLIC ENEMY , CIVIL COMMOTION, EPIDEMICS, or ACT OF GOD (FLOODS, STORM/CYCLONE, HURRICANE, EARTH QUAKE etc) then provided notice of happening of any such event is given by either party to other within 7 days from the date of occurrence therefor neither party shall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such non-performance and delay in performance under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist. If the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event, claims for extension of time shall be granted for periods considered reasonable by the DGM/CCC/FB subject to prompt notification by the Contractor.

10 INSURANCE COVERAGE AND CLAIM

10.1 Insurance

Transit insurance of the consignment under transportation by the Transporter will be responsibility of BHEL/Consignee as the case may be and Transport Carrier shall ensure the insurance coverage. However, Transporter will be responsible for any external damages as per Sec. 8 of Carriers Act, 1865.

10.1.1 The Contract as entered into between BHEL and the Transporter(s) shall in no way nullify, reduce, mitigate or absolve the parties of any responsibility, obligation or liability that may devolve upon them under the Carriers Act, 1865 as amended up to date.

10.1.1.1 Position as above shall not absolve the Transporter of his responsibility for safe and proper transportation of the goods to the proper destination or his liability to compensate for the damage/ shortage / loss in respect of the consignments transported by him.

10.1.1.2 The Transporter's consignment note (LR) shall be acceptable to insurance company. In addition, the Transporter shall get 'LEGAL LIABILITY' from Insurance Company for Insurance Cover.

10.2 Damage / Loss

10.2.1 If any remark is made by the Consignee while delivering the consignment with respect to damage / shortage or loss i.e. total or partial, the Transporter after delivery of the consignment shall inform the agency responsible for booking the consignment or CCC/LOGISTICS within a week of delivery and the Transporter should submit the Xerox copy of LR with covering letter to the Consignor or Consignee (Supplier or Customer or BHEL Unit, Region or Site and/ or CCC/LOGISTICS as applicable).

10.2.2 On receipt of this information, BHEL Trichy (Shipping / CCC) will refer this to the concerned Commercial department. Commercial department will advise in writing, the value of damage / shortage or any other comments to Shipping / CCC so that further action will follow.

10.2.3 In case Commercial cannot assess the extent of damage / shortage immediately, they will advise accordingly so that, after taking necessary documents such as Indemnity Bond from Transport Carriers and Shipping / CCC shall process the bills accordingly.

10.3 Open Delivery

10.3.1 In case of any visible damage/ suspected damage in the consignment, the Carrier should arrange delivery of the consignment on "OPEN DELIVERY" and the open delivery certificate should be issued along with the consignment, duly signed by both parties.

10.4 Non-acceptance of insurance claim lodged by BHEL and Carriers responsibility.

10.4.1 Logistics /Shipping are ensuring that the vehicle placed is loaded, taking cognizance of the passing weight of the RC book copy presented by the Carrier. However Carrier has to own responsibility for the RC Book copy presented at the time of loading and also ensure that the loading is done inline with the passing weight of the RC Book of the vehicle. In the event of any accident / damage visibly seen or inflicted to the consignment which could not be seen visibly but that could be found at the site at any point of time, BHEL would take up with underwriters and lodge claim. If the underwriter observes during the course of survey or otherwise that the vehicle was overloaded beyond RC Book capacity, the claim will be out rightly rejected. In such case the Carrier is totally responsible and contractually bound to compensate fully the total damage, cost involved in rectification or the value of the insurance claim lodged as the case may be, within 30 days from the date of such communication received from BHEL for compensation. In case Carrier fails to compensate with the above period, BHEL will exercise their right to recover such compensation by deduction from such Carriers pending Bills / EMD / SD.

10.5 Accidents

- 10.5.1 All accidents at any point shall be reported to agency concerned and CCC/LOGISTICS in writing through mail followed by hard copy. Failure to send communication will be viewed seriously resulting in suspension or termination of the Contract as deemed fit over and above the recovery of value of the consignment lost or damaged – total or partial.
- 10.5.2 Further, any accident that occurs while the consignment which is booked in transit shall also be brought to the notice of Consignor or consignee and/ or CCC/LOGISTICS as applicable. Subsequently, the F.I.R. and Survey Report by authorized insurance agency (for the damage or loss of consignment en route) shall also be submitted. BHEL Site officials or concerned Shipping agency shall be informed in writing through Mail, Fax or Letter and CCC/LOGISTICS for Incoming consignment and Purchase & Site for DTS consignment within 48 hours of incident or accident or loss or damage to enable the agency responsible to lodge and settle the claims with Underwriters.

In case, the Transporters fail to send communication in respect accident or damage or loss or act on the above lines and insurance claim is not made or compensation obtained by the authorized agency, the recovery will be effected for the value of damage or loss – total or partial of the subject consignment. Suitable action including suspension, de-listing or termination of the Contract as deemed fit.

11 TIMINGS & PROCEDURE FOR DELIVERY/COLLECTION OF CONSIGNMENTS AT BHEL:

- 11.1.1 The vehicle should report to BHEL Premises in between 08.30 AM to 11.30 AM in the MORNING and 1.30 PM and 3.00 PM in the AFTERNOON for delivery of the consignments pertaining to BHEL.
- 11.1.2 BHEL Security regulations shall be followed by the Carrier.
- 11.1.3 Environmental Management Systems (EMS) regulations of BHEL shall also be observed while in BHEL complex and at the time of carrying BHEL materials.
- 11.1.4 Wherever ROAD PERMIT is issued to transport carriers, the carrier should get an acknowledgement from the consignee on the back of G.C itself that the "Counter Foil/Copy of Form.31 received" while getting acknowledgement for receipt of goods. Otherwise any loss on account of this will be recovered from the Carrier and the recovery will be as per the applicable amount at that point of time.

12 SECURITY DEPOSIT

The successful Tenderers shall furnish Security Deposit in any one of the following modes within 15 days from the date of Letter of Intent. The Security Deposit shall be furnished by the successful Tenderers before commencement of work by them:-

12.2 Mode of Remittance of Security Deposit

- 12.2.1 Pay Order, Demand Draft in favour of BHEL.
- 12.2.2 Local cheques of scheduled banks, subject to realization.
- 12.2.3 Securities available from Post Offices such as National Savings Certificates, Kisan Vikas Patras etc. (Certificates should be held in the name of Contractor furnishing the security and duly pledged in favour of BHEL and discharged on the back).
- 12.2.4 Bank Guarantee from Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. The Bank Guarantee format should have the approval of BHEL.
- 12.2.5 Fixed Deposit Receipt issued by Scheduled Banks / Public Financial Institutions as defined in the Companies Act. The FDR should be in the name of the Contractor, A/C BHEL, duly discharged on the back.
- 12.2.6 Security deposit can also be recovered at the rate of 10% from the running bills. However in such cases at least 50% of the Security Deposit should be collected before start of the work and the balance 50% may be recovered from the running bills.
- 12.2.7 Acceptance of Security Deposit against Sl. No. (12.2.3) and (12.2.5) above will be subject to hypothecation or endorsement on the documents in favour of BHEL. However, BHEL shall not be liable or responsible in any manner for the collection of interest or renewal of the Documents or in any other matter connection therewith.
- 12.2.8 EMD of the successful Tenderer will be converted and adjusted against the Security Deposit**

12.3 Refund of Security Deposit

- 12.3.1 The security deposit shall be refunded after successful completion of the Contract as per agreement and subject to deduction of any amount due to BHEL.
- 12.3.2 Security deposit shall not be refunded to the Contractor except in accordance with the terms of the Contract.

13 BILLS SUBMISSION PROCEDURE TO BE FOLLOWED BY THE CONTRACTOR FOR FREIGHT PAYMENT

13.1 Bill Submission

- 13.1.1 All Inward/Outward booking of consignment to be made on "To be billed at Tiruchy" basis only. Bookings on "Freight payable by Customer / Supplier / Site " basis for outward consignments may be done on specific request by BHEL Officials not below the rank of MANAGER of the User Department concerned.
- 13.1.2 All bookings from outstation branches should indicate consignee's designation/ department / purchase order particulars, Ward Number, location of receiving area etc. in the docket for handing over of materials without any problem.

13.2 Documents to be enclosed along with freight claim bill:

- 13.2.1 Freight bill as per approved rates of Contract.
- 13.2.2 Demand Copy. For BHEL Trichy Outbound despatches, BHEL gate Pass shall also be enclosed.

- 13.3.1 All payments to be made to the transporter, shall be through NEFT (National Electronic Fund Transfer / RTGS(Real Time Gross Settlement) within reasonable time, say one month (or as mutually agreed) , after receipt of the bill along with consignee's acknowledgement.
- 13.3.2 Wherever applicable payments to be made to the Contractor, under this Contract shall also be by "CHEQUE" crossed "A/C PAYEE ONLY" within a reasonable time say one month (or as mutually agreed), after receipt of the bill along with consignee's acknowledgement.

14 RISK PURCHASE

In the event of any successful Tenderer's failure to fulfill any of the tender / Contract obligations including non lifting of consignment/s as per Contract / Agreement BHEL may entrust the job to alternate Transport Carrier and get it completed to meet BHEL requirement and additional expenditure, if any, including consequential cost viz., demurrage etc., will be fully recovered from the Tenderer Contractor who failed to complete the job in line with Contract.

The decision of BHEL with regard to the actual losses / consequential expenditures incurred by BHEL shall be final and binding on the Tenderer / Contractor.

15 ARBITRATION

Any dispute arising out of this Contract shall be referred to the Executive Director, Bharat Heavy Electricals Limited, Tiruchirapally-620014 or his authorised Representative for sole arbitration at Trichy and his decision shall be final and binding on both the parties.

16 JURISDICTION

In case of any suit or other legal proceedings arising under or relating to this Contract, the courts at Trichy, Tamil Nadu only shall have the Jurisdiction and is only after exhausting the Arbitration as mentioned in the above clause.

17 OTHERS

- 17.1.1 The transport Carrier shall execute the contract diligently adhering to the terms and conditions of the contract. In the event of poor performance, suitable action, including delisting, will be initiated as per the terms and conditions of the contract.
- 17.1.2 BHEL has the right to extend or short close the Contract if required.
- 17.1.3 The General and Special Conditions of Contract are complementary to each other and where they are in conflict the Special Conditions of Contract shall prevail.
- 17.1.4 The 1.Special Instructions, 2.Special Conditions of the Contract, 3.General Terms & Conditions 4.Safety Conditions, 5.OCP and shall all be integral part of the Contract.

GENERAL TERMS & CONDITIONS OF THE CONTRACT

1 GENERAL TERMS:

1.1 Definitions

In these General Conditions of Contract, the following terms shall have the meaning hereby assigned to them, except where the context otherwise requires:-

- 1.1.1 The "**Contract**" means, the documents forming the tender and acceptance thereof, together with all the documents referred to therein including general and special conditions to contract. All these documents as applicable taken together shall be deemed to form one contract and shall be complementary to one another.
- 1.1.2 The "**work**" means, the work described in the tender documents in individual work-orders as may be issued from time to time to the contractor by the Officer-Incharge within the power conferred upon him including all notified or additional items of works and obligations to be carried out as required for the performance of contract.
- 1.1.3 The "**contractor**" means, the individual Firm or Company whether incorporated or not, undertaking the work and shall include the legal personal representatives of such individuals or the persons composing the firm or Company or the successors of the firm or company and the permitted assigns of such individual or firm or Company.
- 1.1.4 "**The Officer-In charge**" means, the Officer deputed by the DGM/CCC/Logistics, to supervise the work or part of the work.
- 1.1.5 "**Approved**" and "**Directed**" means, the approval or direction of Sr.Manager/CCC/Logistics,, or person deputed by him for the particular purposes.
- 1.1.6 "BHARAT HEAVY ELECTRICALS LIMITED" (herein after referred to as BHEL) shall mean the Board of Directors, Chairman, Executive Director, General Manager or other Administrative Officer of the said Company including DGM/CCC/Logistics authorised to invite tenders and enter into contract for works on behalf of the Company.
- 1.1.7 The "**Contract sum**" means, the sum accepted or the sum calculated in accordance with the prices accepted in tender and / or the contract rates as payable to the contractor for the execution of the work during the currency of the contract.
- 1.1.8 A "**week**" means, Seven Days, without regard to the number of hours worked or not worked in any day in that week.
- 1.1.9 A "**day**" means, the day of 24 hours (TWENTY FOUR) irrespective of the number of hours worked or not worked in that day.
- 1.1.10 A "**working day**" means, any day other than that prescribed by the NEGOTIABLE INSTRUMENTS ACT as being a Holiday, and consists of the number of hours of labour as commonly recognised by good employers in the trade in the district where the work is carried out or as laid down in the BHEL regulations.

2 GENERAL CONDITIONS :-

The heading to these conditions shall not affect the interpretations thereof.

2.1 Work to be carried out:-

2.1.1 The Contract shall, include all labour, materials, tools, plant, equipment and transport which may be required for the execution of the work. The Contractor will be deemed to have satisfied himself as to the nature of the site, local facilities of access and all matters affecting the execution of the work. No extra charges consequent on any misunderstanding in these respects or otherwise will be allowed.

2.2 Deviations:-

2.2.1 The contractor shall not carry out any work not covered by schedule except in pursuance of the written instructions of DGM/CCC/Logistics, No such work shall be valid unless the same has been specifically confirmed and accepted by BHEL in writing and incorporated in the Contract.

2.3 Octroi And Other Duties:-

2.3.1 All charges on account of Octroi terminal or Sales Tax and or other Duties on materials obtained for the work shall be borne by the Contractor.

2.4 Plant and Equipment:-

2.4.1 The Contractor shall at his own expense, supply all tools plant and equipment (Herein after referred to as T&P) required for the execution of the contract.

2.5 Assignment Of Transfer Of Contract:-

2.5.1 The Contractor shall not without the prior written approval of the BHEL, assign or transfer the contract or any part thereof, or any share, or interest thereon to any other persons. No sum of money which may become payable under the contract shall be payable to any person, other than the contractor unless the prior written approval of the BHEL to the assignment or transfer of such money is given.

2.5.2 **SUB-CONTRACT :-** The Contractor shall not sub-let any portion of the contract without the prior written approval of the BHEL .

2.6 Compliance to regulations and by-laws :-

2.6.1 The Contractor shall confirm to the provisions of any statute relating to the work and regulations and Bye-Laws of any local authority. The Contractor shall be bound to give all notices required by statute regulations or By-Laws as aforesaid and to pay all fees and taxes payable to any authority in respect thereof.

2.7 Security deposit:-

- 2.7.1 The security deposit shall not carry any interest.
- 2.7.2 The Earnest Money paid at the time of tender will be adjusted as part of the Security Deposit and the balance amount will be recovered by deduction from the running bills of the contractor.
- 2.7.3 Security Deposit shall not be refunded except in accordance with the terms of Security Bond or Agreement. No interest shall be allowed on Security Deposits. BHEL shall not be responsible for any loss of securities, due to liquidation for any other reasons, what-so-ever or any depreciation in the value of the securities while in their charge or for any loss of interest there on.
- 2.7.4 All compensation or other sums of money payable by the Contractor to BHEL under the terms of this contract or under any other contract with BHEL may be deducted from the Security Deposit or realised by the sale of the securities or from the interest arising therefrom or from any sums which may be due or may become due to the contractor by BHEL and in the event of this Security Deposit being deducted by reason of such deductions or sale, as aforesaid, the Contractor shall within 7 days thereafter, make good in cash or in securities endorsed as aforesaid, any sum by which the Security Deposit has been reduced.

2.8 Refund of security deposit:-

- 2.8.1 The Security Deposit mentioned above may be refunded to the Contractor after a period of 6 months on termination or expiry of the contract provided always that the Contractor shall first have been paid the last and final bill and have rendered a "NO DEMAND CERTIFICATE".

2.9 Orders Under The Contract:-

- 2.9.1 All orders, notices etc. to be given under the contract shall be in writing, type-script or printed and if sent by registered post to the address given in the tender of the Contract, shall be deemed to have been served on the date, when in the ordinary course they would have been delivered to him. The Contractor shall carry out without delay all orders given to him.

2.10 Contractor's Supervision:-

- 2.10.1 The Contractor shall either himself supervise the execution of the contract or shall appoint a competent agent acceptable to the DGM/CCC/Logistics, to act in his stead.
- 2.10.2 Orders given to the Contractor's agent shall be considered to have the same force as if they have been given to the Contractor himself.
- 2.10.3 The Contractor or his accredited agent shall attend when required without making any claim for doing so, either the office of the Sr.Manager/CCC/Logistics or the OFFICER-INCHARGE, to receive instructions.
- 2.10.4 The DGM/CCC/Logistics, shall have full powers and, require the Contractor to immediately cease to employ in connection with this contract, any agent, servant or employee where continued employment is, in his opinion undesirable. The Contractor shall not be allowed any compensation on this account.

2.11 Labour:-

- 2.11.1 The Contractor shall remain liable for the payment of all wages or other moneys to his work-people or employees under the payment of Wages Act 1936, Employees Liability Act. 1938, Workmen's Compensation Act 1923 or any other Act or enactment, relating thereto and rules framed, thereunder from time to time.

2.12 Precautions against Risk:-

2.13 Damage & Loss to Private Property & Injury to Workmen:-

- 2.13.1 The Contractor shall at his own expense reinstate and make good to the satisfaction of the DGM/CCC/Logistics, and pay compensation for any injury, loss or damage occurred to any property or rights whatever including property and rights of BHEL (or agents) servants or employee of BHEL, the injury loss or damage arising out of or in any way in connection with the execution or purported execution of the contract and further the contractor shall indemnify, the BHEL against all claims enforceable against BHEL (or any agent, servant or employee of BHEL) or which would be so enforceable against BHEL where BHEL is a private person, in respect of any such injury (including injury resulting in death) loss or damage to any person whomsoever or property including all claims which may arise under the Workmen's Compensation Act or otherwise.

2.14 Laws Governing The Contract:-

- 2.14.1 The contract shall be governed by the Indian Laws for time being in force.

2.15 Cancellation Of Contract For Corrupt Acts:-

- 2.15.1 BHEL , whose decision shall be final and conclusive, shall without prejudice to any other right or remedy which shall have accrued shall accrue thereafter to BHEL cancel the contract in any of the following cases and the Contractor shall be liable to make payment to BHEL for any loss or damage resulting from any such cancellation to the same extend as provided in the case of cancellation for default.

If the Contractor shall :-

- 2.15.2 Offer or give or agree to give to any person in BHEL service any gift or consideration of any kind, as an inducement or reward for doing or for bearing to do or for having done or for borne to do any act, in relation to the obtaining or execution of this or any other contract for BHEL service,
OR
- 2.15.3 enter in to a contract with BHEL in connection with which commission has been paid or agreed to be paid by him or with his knowledge, unless the particulars of any such commission and the terms of payment thereof have previously been disclosed in writing to BHEL.
OR
- 2.15.4 obtain a contract with BHEL as a result of ring tendering or by non-bonafide methods of competitive tendering, without first disclosing the fact in writing to BHEL.

2.16 Cancellation Of Contract For Insolvency Assignment Of Transfer Or Sub-Letting Of Contract:-

- 2.16.1 BHEL, without prejudice to any other right or remedy which shall have accrued or shall accrue thereafter to BHEL shall cancel the contract in any of the following cases:

If the Contractor,

- 2.16.2 being an individual or if a firm any partner thereof shall at any time be adjudged bankrupt or have a receiving order for administration of his estate, made against him or shall take any proceedings for liquidation or composition under any bankruptcy Act or assignment of his effects of composition or arrangement for the benefit of his creditors or purport to do so, or if any application made under any

2.16.5 Assigns, Transfers, Sub-lets or attempts to assign, transfer or sub-let any portion of the work without the prior written approval of the BHEL .

2.16.6 Whenever BHEL exercise the authority to cancel the contract under this conditions, BHEL may have the work done by any means at the Contractor's risks and expenses provided always that in the event of the cost of the work so done (as certified by Sr.Manager/CCC/Logistics which is final and conclusive) being less than the contract cost, the advantage shall accrue to the BHEL and if the cost exceeds the money due to Contractor under the contract, the Contractor shall either pay the excess amount ordered by DGM/CCC/Logistics, or the same shall be recovered from the Contractor by other means.

2.16.7 In case the BHEL carries-out the work under the provisions of this condition the cost to be taken into account in determining the excess cost to be charged to the Contractor under this condition shall consist of the cost of the materials, hire charges of tools and plants and/or labour provided by the BHEL with an addition of such percentage to cover superintendence and establishment charges as may be decided by the DGM/CCC/Logistics, whose decision shall be final and conclusive.

2.17 Cancellation of Contract in Part or Full for Contractor's Default:

If the Contractor :

1.1.11 makes default in carrying out the work as directed and continues in that state after a reasonable notice from DGM/CCC/Logistics, or his authorised representative ;

1.1.12 fails to comply with any of the Terms and Conditions of the contract or after reasonable notice in writing with orders properly issued thereunder ;

1.1.13 BHEL, may without prejudice to any other right or remedy which shall have accrued or shall accrue thereafter to BHEL CANCEL the contract as whole or in part thereof or only such work order or items of work in default from the contract. If the cost exceeds the moneys due to the Contractor under this contract the Contractor shall either pay the excess amount ordered by Sr.Manager/CCC/Logistics or the same shall be recovered from the Contractor by other means. In case the BHEL carries out the work or any part thereof under the provisions of the conditions the cost to be taken into account in determining the excess cost to be charged to the Contractor under this condition shall consist of the cost of the materials, hire charges of tools and plant and/or labour provided by the BHEL with an addition of such percentage to cover the superintendence and establishment charges as may be decided by the DGM/CCC/Logistics, whose decision shall be final and conclusive.

2.18 Termination Of Contract On Death Of Contractor. :-

Without prejudice to any of the rights or remedies under this contract, if the Contractor dies, or if the firm is dissolved or the company is liquidated BHEL shall have the option of terminating the contract without compensation to the Contractor.

Mechanical failure / breakdown of vehicle is not considered under this clause for extension.

Contracts by a Company shall be signed with the name of the Company by a person authorised in this behalf and a power of attorney or other satisfactory proof showing that the persons signing the Contract documents on behalf of the Company is duly authorised to do so, shall accompany the contract.

2.26 Statutory Requirements:

2.31 Employer Interests:-

2.31.1 Contractor shall watch and safeguard Employer's interests during the performance of the work. The Contractor shall carefully check each consignment with the relevant despatch documents to ensure correctness of each despatch and each delivery.
