The suppliers who are availing SIDBI/HDFC discounting facility (pay by BHEL in about 120 days from the date of invoice) with us will continue to get this facility. However, due to funds problems, this facility cannot be extended to other suppliers. These payment terms will be treated as standard terms of payment. The bidder who are covered under MSMED Act-2006 &amp; quoted 45 days of payment after acceptance of material will also be treated as standard terms of payment.</p> <p><b>Any other payment term like:</b>          Advance/LC/CAD (cash against dispatched documents) etc. will not be accepted from indigenous vendors.
