- ** Cost quoted / arrived from sl. no. 10 to 13 will NOT be considered as a part of PRICE BID for EVALUATION PURPOSE. However same will be CONSIDERED for arriving TOTAL CONTRACT VALUE.
- Total Contract Value = Part I + Part II + III Any other Taxes (mention type of tax & rate with details)
- Bills will be paid once two months.
- Labour payment should be made before 7th day of every month, other wise 0.50% penalty on gross value work executed will be levied for every day's delay in making payment subject to a maximum of 10% on each occasion.
- For non supply of Tractor, a penalty of Rs 1300 per day will be recovered.
- For non supply of tools, penalty of actual cost will be recovered as per market rates.
