**TERMS AND CONDITIONS (In conjunction with Tender Enquiry Letter terms) :**

**1. Pre-Qualifying Requirements:**

Bidders have to provide the required details as per "TECHNICAL AND FINANCIAL PRE-QUALIFYING REQUIREMENTS" (enclosed as NIT Tender Documents). Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.

2. Bidders have to note that this is a conditional Global Tender enquiry. Price bid (Part-II) opening/RA participation of those bidders, who are not approved by Customer, shall be subjected to approval of bidder by Customer and techno-commercially recommended bidder of BHEL.

3. Bidders have to note that TERMS AND CONDITIONS of the tender shall be as per General Conditions of Contracts (GCC, Rev. 06), Special Conditions of Contract and as per these Notice Inviting Tender (NIT) conditions. Order of precedence shall be as per clause NO. 35.0 of GCC Rev. 06 (GENERAL COMMERCIAL TERMS & CONDITIONS).

Vendor shall submit drgs/docs within 15 days from the date of PO and resubmission within 10 days of our comment. In case there are delays in submission/re-submission of documents beyond 15 days of PO or 10 days of comments, that much days of delay would be reduced from delivery period.

**For Electrolyte:** Within 02 months from the date of clearance for dispatch by BHEL.

**Supervision of E&C:** Supplier to deploy its engineer at project site within 15 days of BHEL intimation.

6. Separate order shall be placed for the supply of Electrolyte for DC batteries and the same shall be supplied only after dispatch clearance from BHEL. Separate Guarantee terms shall be applicable for electrolyte as per GCC Rev. 06.
7. Evaluation shall be done on total lump sum (total cost to BHEL) basis.
8. Online Registration Portal is operational in BHEL. Non-registered Vendors, who wish to apply for registration with BHEL-PEM, have to apply through Online Registration Portal available at [www.bhelpem.com](http://www.bhelpem.com) ' vendor section ' Online Supplier Registration. All credentials and/or documents duly signed and stamped related to registration has to be uploaded on the website and submit the application for registration. One set of hard copy of the filled-up SRF downloaded from Online Registration Portal duly signed and stamped has to be submitted.
9. CIF is not available for this package.
10. Insurance (Ocean and inland) is in BHEL's scope.
11. Bidder has to refer Technical specification # PE-TS-410-508-E001, VOI-II B, SECTION-C, SHEET 16 of 39, S.NO. 9.4 in regard to Type Test-"Capacity test and test for voltage on battery during discharge", indicated in BOQs cum Price schedules. Payment terms for this test shall be as per clause no. 9.5 of GCC Rev. 06.
12. Bidders have to note that Deviations from NIT are generally not acceptable. Deviations, if any, are to be listed out clearly, as per Annexure-II, of GCC Rev 06, in techno-commercial offer. Any deviation mentioned or shown separately or found hidden in offer, will not be taken cognizance of.

In case of deviations from NIT, the bidder shall give the cost of withdrawal of such deviation in Sealed Cover as per Annexure-II, Deviation Sheet (Cost of Withdrawal), as per GCC Rev-06.
