

**BHARAT HEAVY ELECTRICALS LIMITED,

Instruction to Bidders and Special Terms and conditions for supply of cold rolled, Non-Grain oriented sheet steel for stator of Yadadri Project. Requirement is issued under a open tender enquiry no. **TE/130150004/C/09** dated **26/07/2015** due on **17/08/2015** for CSU Jagdishpur. Sealed offers are invited in **Two-Part Bid** for procurement of Cold Rolled NGO and magnetic steel.

- a) Quantity Tolerance of +/- 5% is permissible for shipping tolerance.
- b) Quantity variation of +30% as per requirement with mutual consent.
- c) **Coating thickness:** For details refer specific clause of each specification.
 - i. 1-JP : As per clause 3.3 (a) of spec AA10915 Rev 08 , 6 +/- 1 microns thickness on double sides insulated on each side with varnish as per BHEL spec AA 27541.
- d) Maximum coil weight of 5.5 (+/- 0.5) MT, Max OD: 1500mm & Min ID: 500mm is permissible.
- e) Quantities indicated against each size are indicative and tentative in nature. BHEL reserves the right to change quantity allocation among sizes within specific grade however in the manner that ordered quantity will not exceed tendered cumulative quantity.
- f) BHEL reserves the right to order for nearby size with the quote available against a specific size.

2. Qualifying criteria

- a. "**BIS license for supplying mill:** - BIS certification is mandatory for Cold Rolled NGO supplying mill from **01-Jul-2014** onwards or as per the Steel and Steel Products (Quality control) Second (Amendment) Order, 2012 dated 31.03.2014. Offer in line with Steel quality control order shall only be considered for further evaluation and price bid opening."
- b. Vendors not registered with BHEL to supply required grade material OR quoting first time for specific cold rolled, Non-Grain oriented sheet steel (Insulated) requirement should have experience of supplying similar product for electrical equipment supported by client certificate.

3. Clause by Clause acceptance

- A. Bidder shall confirm clause by clause acceptance to all the terms and conditions of the enquiry, Purchase specification AA10915 Rev 08 and bring out clearly deviations, if any from-
 - a. Purchase specifications
 - b. Terms and conditions contained in this Annexure-I & General Terms & Conditions Annexure –II (Enquiry GCC)
- B. All testing requirement as called in the purchase specifications must be part of the MTC to be issued by the Mill along with the supply.
- C. Purchase orders/payment against order will be issued by BHEL, CSU Jagdishpur. The vendors shall ensure timely dispatches as per delivery schedule indicated in the purchase orders.

4. Evaluation of bids:

- a. Offers will be evaluated on total delivered/landed cost at BHEL CSU-Jagdishpur and will be awarded accordingly.
- b. **Offers will be evaluated on Merit duty.** In case of any change in MOA, the same will be communicated to bidders before price bid opening.

5. **Documentation:** One set of **Original ink signed Test Certificates** shall be sent by Courier addressed to AGM/MM – CSU Jagdishpur after the dispatch of goods to purchasing Units along with other documents as mentioned in the Annexure-II. Vendor should ensure that the Test certificates (TC) issued by them must include Purchase Order no., Customer name i.e., M/s BHEL-CSU Jagdishpur. Test certificates should cover results of tests for Mechanical and Electrical properties as per specification for each Coil No / Heat No.
