PRE QUALIFICATION CRITERIA

S.No.	CRITERIA
1.0	Average annual financial turnover of bidder, during the last three financial years (ending on 31-03-2016 or latest closing date of financial year) should not be less than Rs 20 Lakhs (or) equivalent. Bidder shall enclose balance sheet and ITR of latest last 3 year as proof of Financial standing.
2.0	Experience on similar contracts for last 5 years. Proof of supply of Items same / Similar item should be in the form of purchase orders placed on the vendor by their customer.
