**13. Pre-Qualifying Requirement :**

Bidders are requested to provide the details as per "TECHNICAL AND FINANCIAL PRE-QUALIFYING REQUIREMENTS". Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.

14. Bidder to note that this is a conditional Open (Global) Tender enquiry for those who are not registered with BHEL PEM/ Customer (NTPC) and the price bid (Part-II) opening/RA participation shall be subjected to following criterion:

**a. Approval of bidder by BHEL**

15. Indian bidders have to quote freight charges in percentage of their quoted Total Ex-works prices. Indian Bidder to mention the percentage of freight (of Total Ex Works).

16. Indigenous bidders to quote F.O.R site price and foreign bidders to quote F.O.B port price. However, F.O.R site price for foreign bidders will be calculated by loading their F.O.B port price for evaluation as per GCC Rev.06.
