b. For Erection and Commissioning: Within 3 months from site front availability.

13. Pre-Qualifying Requirement :

Bidders who fulfil TECHNICAL & FINANCIAL PRE-QUALIFICATION REQUIREMENT CRITERIA are eligible to participate in this tender.

Bidders are requested to provide the details as per "TECHNICAL AND FINANCIAL PRE-QUALIFYING REQUIREMENTS". Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.

14. Bidder to note that this is a conditional Open Tender enquiry for those who are not registered with BHEL PEM/ Customer (NTPC) and the price bid (Part-II) opening/RA participation shall be subjected to following criterion:

15. Indian bidders have to quote freight charges in percentage of their quoted Total Ex-works prices. Indian Bidder to mention the percentage of freight inclusive of Service Tax. (of Total Ex Works).

16. Evaluation will be done based on Total Lump sum cost to BHEL (i.e. Total FOR site price for supply plus Total E&C charges with necessary loadings as applicable) as per GCC Rev06.

17. Total erection & commissioning charges including service tax should be minimum 20% (or as specified in NIT) of the total quoted package price (excluding mandatory spares but including all taxes and freight), failing which the break-up of prices shall be adjusted accordingly for ordering.
