TERMS AND CONDITIONS (In conjunction with Tender Enquiry Letter terms) :

1. Pre-Qualifying Requirements:

Bidders have to provide the required details as per "TECHNICAL AND FINANCIAL PRE-QUALIFYING REQUIREMENTS" (enclosed as NIT Tender Documents). Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.

2. Bidders will be informed that this is a conditional OPEN Tender enquiry. Price bid (Part-II) opening/RA participation of those bidders, who are not approved by end Customer, shall be subjected to following:

- I. Approval of bidder by the customer. Same shall be taken up by BHEL with the customer based on the credentials/reference list being submitted by the bidder.
- II. Clause no. 2.2 of GCC Rev06.

3. Bidders have to note that following forms the part of Tender Documents :

13. Delivery Terms :

- a. **Main Supply (along with commissioning spares):** Delivery Completion shall be within 09 months from date of LOA. Above delivery is subject to submission of drg. /docs as per Technical Specification No.: PE-TS-410-554-A001, Rev 0, ANNEXURE-VI (page no.311-312 of 403). Every resubmission, if required, within 07 days of receipt of comments incorporating all BHEL/ (end) Customer comments. BHEL/ (end) Customer will approve/comment on the drg./docs. Within 10 days from the date of submission.
- b. **Mandatory Spares:** Mandatory Spares and Tools & tackles (if any) are to be delivered along with the last consignment of main supply within the contractual delivery period..
- c. **E&C schedule:** Completion shall be within Three (03) months from front released by BHEL (Date for which site informs for mobilization shall be date of clearance of front)..

14. Health, Safety & Environment guidelines for site operations are to be followed by bidders/suppliers.

15. Bank Guarantees should be in favour of BHEL-PSSR in place of PEM. Suppliers will be required to submit BGs to executing agency BHEL-PSSR.

16. Evaluation shall be on over all L1 basis (total cost to BHEL). Bidders have to refer SCC & GCC for the same. Further, Swachh Bharat Cess (i.e. 0.5% of Service Tax rate) applicable on E&C price is not cenvatable. Hence, this 0.5% component of cess on E&C price shall be considered in evaluation.

17. **Total erection & commissioning charges and PG Test Charges including service tax should be minimum 20% of the total quoted package (excluding mandatory spares but including all taxes & freight), failing which the break-up of price shall be adjusted accordingly for ordering.**

18. The Bidder along with its associate/ collaborators/ sub-contractors/ sub-vendors/ consultants/ service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.

19. Bidder has to note that Deviations from NIT are generally not acceptable. Deviations, if any, are to be listed out clearly, as per Annexure-II, of GCC Rev 06, in techno-commercial offer. Any deviation mentioned or shown separately or found hidden in offer, will not be taken cognizance of. In case of deviations from NIT, the bidder shall give the cost of withdrawal of such deviation in Sealed Cover as per Annexure-II, Deviation Sheet (Cost of Withdrawal), as per GCC Rev-06.

20. Foreign bidders quoting along with their Authorised Indian associates to comply with BHEL corporate circular AA:MM:AGENCY dated 06th August 2010 for the guidelines regarding dealings with Indian agents of Foreign bidders (as enclosed).

21. Indian bidders/Foreign Bidders for Indigenous Items have to quote freight charges in percentage of their quoted Total Ex-works prices.

22. Prices shall remain Firm till completion of contract.
23. Online Registration Portal is operational in BHEL. Non-registered Vendors, who wish to apply may apply through Online Registration Portal available at www.bhelpem.com → vendor section → Online Supplier Registration. All credentials and/or documents duly signed and stamped related to registration has to be uploaded on the website and submit the application for registration. One set of hard copy of the filled-up SRF downloaded from Online Registration Portal duly signed and stamped has to be submitted'.
24. MSE suppliers can avail the intended benefits only if they submit along with the offer, attested copies of either EM II certificate having deemed validity (five years from the date of issue of acknowledgement in EM II) or valid NSIC certificate or EM II certificate along with attested copy of a CA certificate (Format enclosed at Annexure-1 where deemed validity of EM II certificate of five years has expired) applicable for the relevant financial year (latest audited). Date to be reckoned for determining the deemed validity will be the date of bid opening (Part 1 in case of two part bid). Non submission of such documents will lead to consideration of their bid at par with other bidders. No benefit shall be applicable for this enquiry if any deficiency in the above required documents are not submitted before price bid opening. Documents should ne notarized or attested by a Gazetted officer.
25. Foreign and indigenous bidders participating in subject tender will necessarily have to buy class III DSCs (Digital Signature Certificate) issued by the certifying authorities in India. Basic procedure /checklist is uploaded on "www.bhel.com" for participating in future tender enquires through e procurement.
26. All other terms & conditions shall be as per GCC Rev-06, SCC Rev-01 for **1X800 MW TSGENCO KOTHAGUDAM TPS** and Notice Inviting Tender (NIT) conditions. Order of precedence shall be as per clause NO. 35.0 of GCC Rev. 06 (GENERAL COMMERCIAL TERMS & CONDITIONS).
27. CIF is not available for this package.
28. **Reverse Auction:**
BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders have to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.
In case BHEL decides to go for Reverse Auction, only those bidders who have given their unconditional acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'online sealed bid' in the Reverse Auction. Non-submission of 'online sealed bid' by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.

Terms and Conditions of RA is attached as Annexure-III. Business rules for RA shall be sent to the bidders before conducting Reverse Auction.
