Drawing / Document Submission Schedule: Submission of all drawing, documents, datasheets, Quality Plan etc. shall be within 03 weeks from the date of PO and every resubmission, if required, within 10 Days of receipt of comments incorporating all BHEL / Customer (GSECL) comments. BHEL / Customer (GSECL) will approve / comment on the drawing/ documents within 10 days from the date of submission. All drawings/ documents shall be approved within 3 months from the date of purchase order.

Supervision of Erection, Testing & Commissioning: Service Engineer/ Supervisor shall be deployed by the bidder for supervision of Erection, testing & commissioning at project site within 30 Days of BHEL intimation.

NOTE: - Keeping in view the above delivery schedule, Essentiality Certificate shall be issued within 08 weeks from the date of furnishing of "Formal" request / application from vendor giving full details of the items to be imported, their quantities, values & source of procurement.

Bidders are requested to provide the details as per "TECHNICAL & FINANCIAL PRE-QUALIFICATION REQUIREMENT". Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.

12. CIF is available for this package. Bidders to quote accordingly.
13. Evaluation shall be done on lump-sum basis on overall L1 basis (Total cost to BHEL) including applicable loading (if any).
14. **Reverse Auction:-** Bidders to quote their best competitive prices. BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit online sealed bid in the Reverse Auction. Non-submission of online sealed bid by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.

MSE suppliers can avail the intended benefits only if they submit along with the offer, attested copies of either EM II certificate having deemed validity (Five years from the date of issue of acknowledgement in EM II) or valid NSIC certificate or EM II certificate along with attested copy of CA certificate (Format enclosed at **Annexure-I** where deemed validity of EM II certificate of five years has expired) applicable for the relevant financial year (latest audited). Date to be reckoned for determining the deemed validity will be the date of bid opening (Part 1 in case of two part bid).
