**TERMS AND CONDITIONS (In conjunction with Tender Enquiry Letter terms):**

**1. Pre-Qualifying Requirements:**

Bidders have to provide the required details as per "TECHNICAL AND FINANCIAL PRE-QUALIFYING REQUIREMENTS" (enclosed as NIT Tender Documents). Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.

2. Bidders has to note that this is a conditional Open Tender enquiry. Price bid (Part-II) opening/RA participation shall be subjected to-

1. Approval of bidder by end customer i.e. TSGENCO.
2. Techno-commercial recommendation bidders by BHEL PEM.

3. Bidders have to note that TERMS AND CONDITIONS of the tender shall be as per General Conditions of Contracts (GCC, Rev. 06), Special Conditions of Contract and as per these Notice Inviting Tender (NIT) conditions. Order of precedence shall be as per clause NO. 35.0 of GCC Rev. 06 (GENERAL COMMERCIAL TERMS & CONDITIONS).

**5. Delivery Terms:**

Manufacturing of Lot-I quantities shall be done after the approval of technical and quality documentation, and Supply of same shall be completed within four months of date of approval of documents.

Subsequent lots, if any shall be cleared for manufacture based on progress of engineering and site requirements. A lead-time of three months shall be given for completion of supply of each lot from the date of clearance of the quantities"

First submission of Drawings/Documents shall be as per Annexure-B (List of Standard Deliverables) of Technical Specification No. PE-TS-411-507-E005. Every re-submission (if any) incorporating all BHEL/Customer comments shall be within 07 days from comments.

In case there is delay in submission/resubmission of drawing/document, that delay will be adjusted to reduce the delivery period.

6. Evaluation will be done on overall L1 (total cost to BHEL) basis. Bidder has to refer SCC & GCC for the same.
7. PVC shall be applicable and shall be as per PVC Annexure-A.
8. CIF is not available for subject package.
9. Online Registration Portal is operational in BHEL. Non-registered Vendors, who wish to apply for registration with BHEL-PEM, have to apply through Online Registration Portal available at [www.bhelpem.com](http://www.bhelpem.com) -> vendor section -> Online Supplier Registration. All credentials and/or documents duly signed and stamped related to registration has to be uploaded on the website and submit the application for registration. One set of hard copy of the filled-up SRF downloaded from Online Registration Portal duly signed and stamped has to be submitted.
10. Bidders have to note that Deviations from NIT are generally not acceptable. Deviations, if any, are to be listed out clearly, as per Annexure-II, of GCC Rev 06, in techno-commercial offer. Any deviation mentioned or shown separately or found hidden in offer, will not be taken cognizance of. In case of deviations from NIT, the bidder shall give the cost of withdrawal of such deviation in Sealed Cover as per Annexure-II, Deviation Sheet (Cost of Withdrawal), as per GCC Rev- 06.

Non-submission of online sealed bid by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.
