**8. Delivery Terms :**

**Main Supply:** The quantities will be released for manufacture in more than one lot. Manufacturing of Lot-I released with PO shall be done after the approval of technical and quality documentation, and supply of same shall be completed within Four (4) months from the date of approval of drgs/ docs. Approval in CAT-I.

Drawing Document Submission Schedule: First submission of drg. /docs shall be as per point no. 3.2 of Section-C of Technical Specification no. PE-TS-410-507-E003 and every resubmission, if required, within 10 days of receipt of comments incorporating all BHEL comments.

Bidder to note that drawings submitted shall be complete in all respects with revised drawing submitted incorporating all comments .Any incomplete drawing submitted shall be treated as non-submission with delays attributable to bidder's account .Any delay in submission/resubmission shall be reduced from delivery period.

**Subsequent Lot:** A lead-time of Three (3) months from the date of LOT clearance shall be given for completion of supply for each subsequent lot based on progress in engineering & site.

9. Evaluation shall be on over all L1 basis (total cost to BHEL). Bidders have to refer SCC & GCC for the same.
10. Indian bidders/Foreign Bidders for Indigenous Items have to quote freight charges in percentage of their quoted Total Ex-works prices.
11. PVC shall be applicable for the subject package as per Annexure-B.

16. MSE suppliers can avail the intended benefits only if they submit along with the offer, attested copies of either EM II certificate having deemed validity (five years from the date of issue of acknowledgement in EM II) or valid NSIC certificate or EM II certificate along with attested copy of a CA certificate (Format enclosed at Annexure-1 where deemed validity of EM II certificate of five years has expired) applicable for the relevant financial year (latest audited). Date to be reckoned for determining the deemed validity will be the date of bid opening (Part 1 in case of two part bid). Non submission of such documents will lead to consideration of their bid at par with other bidders. No benefit shall be applicable for this enquiry if any deficiency in the above required documents are not submitted before price bid opening. Documents should ne notarized or attested by a Gazetted officer.

20. Vendors are not allowed to change /modification their collaborator/ JDU partner after Part-I opening.
21. **Reverse Auction:**  
BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders have to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.  
In case BHEL decides to go for Reverse Auction, only those bidders who have given their unconditional acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'online sealed bid' in the Reverse Auction. Non-submission of 'online sealed bid' by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.
