- 1.1 Supply of **(Earthing Material for Mangdechhu Project)**.
- 1.2 Acceptance Norms: As per standard IS:7887 (1992) Grade-8
- 1.3 Please quote in Indian rupee, offer received in other currency will not be accepted.

NOTE:

- 1) All MS Rods shall be of the same/equal length.
- 2) Vendor to specify the following details item wise in their bids:
 - a) Length of MS Rods.(each unit length should be 6 MTR not more than 6 Mtr)
 - b) Total Number of MS RODS
 - c) Total weight of MS RODS
 - d) In Meters: Quantity of MS RODS DIA 40MM, Quantity of MS RODS DIA 40MM =Approx. 35500 mtr
 - e) Length above 6 meter is not accepted due to logistics reasons.
 - f) Successful Bidder should submit the QAP as per enclosed format.
 - g) Quantity variation: $\pm 10\%$

Batch Test Certificate: Mechanical & chemical test certificates as per material specification & relevant is standard mentioned. Vendor has also to confirm co-relation between material & TC included co-relation with parent ingot test certificate and dimensional report. The material shall be free from rust.

Non submission of such documents will lead to consideration of their bids at par with other bidders and MSE status of such suppliers shall be shifted to Non MSE suppliers till the supplier submits these documents.”

1. COMMERCIAL TERMS AND CONDITIONS

Price: Price should be quoted strictly as per proforma for price bid, FOR destination basis Inclusive of transportation (Quote separately), or any other transit expenditure. Vendor has to supply the item at delivery place mentioned in Cl.1.7.

- For bid evaluation, price will be calculated on the basis of landed cost to BHEL as per the price proforma.

Documents Required : Vendor has to submit the following documents in Eight Sets :

- a) Batch Test certificate: mechanical, electrical, chemical properties as per IS: 7887-1992 Grade-8 to furnish before dispatch.
- b) Guarantee Certificate valid for 18 months from the date of supply of material.
- c) Completely filled Annexure-II of NIT in Price Bid envelope.

1.2 **Validity of Offer:** - 90 days from the date of technical bid opening.

1.3 **Price variation clause:** Price offered should remain firm till the supply of material.

1.4.1 **Delivery Period:** Within **4 weeks Ex-works**. Early delivery is preferred.

1.4.2 **Delivery Schedule:** **4 weeks**.

The Material is required to complete the project in stipulated time. Vendors are required to accept the delivery schedule stated above. In case BHEL does not get sufficient response accepting our delivery schedule, then offer with deferred scheduled will be accepted up to **6 weeks**. In such case loading on their basic price will be done @0.5% per week of Basic Price to calculate the landed cost to BHEL. Offer with delivery beyond 6 weeks will not be considered.

1.5 **Delayed Delivery Penalty:** LD shall be 0.5 % of the order value per week of delay or part thereof subject to a maximum of 10% of the full order value. In case of any change to the order value, the LD shall be 0.5% of the revised order value per week of delay or part thereof subject to a maximum of 10% of revised order value. In case of staggered delivery schedule, LD shall be 0.5 % per week of delay or part thereof subject to a maximum of 10% of the undelivered portion.

1.6 **Place of dispatch:** - The vendor has to clearly specify the place from where material will be dispatched.

1.7 **Delivery Place:**

1.8 Transportation: Shall be arranged by Vendor. Vendors offer should give Price Break-up. i.e. Ex-works/Ex-Go down & Transportation. In case vendor quote ex-works price without transportation, their prices will be loaded as per BHEL transport.

1.9 Packing & Forwarding: Price should be quoted inclusive of all Packing & Forwarding charges.

1.10 Payment Terms:

- Payment of 90% of Order Value will be made within 90 days (45 days for MSMED) of submission of bills with proof of receipt of material from our site representative (Original receipted LR to be submitted).
- Balance 10% after completion of total supply within 90 days (45 days for MSMED vendor).
- 100% payment will be made within 90 days (45 days for MSME vendor) if total supply is complete in one lot.
- Progressive payment can be made after deduction of L.D, if any as & when the items are dispatched from your works.
- Payment will be made through e-payment only. Vendor should furnish bank details if not submitted earlier.
- In case, of any deviation to the payment terms mentioned above, loading shall be done on basic price with the PLR (prime lending rate) of SBI + 2% for the period of relaxation sought by the bidder (PLR shall be considered from the date of technical bid opening).

1.11 Taxes & Duties: Bidders to clearly specify the taxes and duties applicable on the date of submission of offer. However, any statutory variation in the rates and taxes and duties after the date of submission shall be considered and actual rates applicable at the time of dispatch of material shall be payable at actual against documentary evidence.

1.11.1 Excise Duty: This being a physical export, Excise duty exempted. Necessary documents will be provided at the time of dispatch. Vendor has to submit excise registration details & other relevant documents to avail ED exemptions,.

1.11.2 Sales Tax: This being a physical export, sales tax is exempted; 'H' form will be provided to the successful bidder.

1.11.1 For tender evaluations, Excise duty & sales tax will be considered as NIL.

1.12 Transit Insurance :By BHEL

1.12a Octroi charges/Entry Tax if applicable: Not Applicable. Road Permit will be issued to the vendor, if applicable.

1.13 Inspection: BHEL / or its customer / TPI shall inspect the material before dispatch. In the event BHEL / customer waives off inspection, certified test report and results shall be submitted for approval. Vendor has to submit QAP's along with all the relevant Test certificates / Calibration certificates & Obtain approval on test report and Material dispatch Clearance Certificate, MDCC/MICC before dispatch of material.

1.14 Interpretation of Contract: In case of two or more than two interpretations or differences in any of the technical specifications or terms and conditions of the contract then the interpretation which is in favour of BHEL shall be final & binding

1.15 Evaluation Criteria: Price evaluation shall be done on the basis of landed cost to BHEL.

2 PROCEDURE FOR SUBMISSION OF TENDER

- 2.1 Bidder shall submit the offer in two bid system in two different sealed covers.
- 2.2 Part 'A': Techno-Commercial Bid
- 2.3 Part 'B': Price Bid
- 2.4 **Tender No., date and due date of opening should be written on both the covers.**
- 2.5 These two covers shall then be placed in a large cover and sealed. The Large cover should also have Tender no., Date and Due Date. This should be dropped in the tender box placed at the entrance of our works before due date and time.
- 2.6 **Part 'A' - Techno Commercial Bid:** Techno Commercial Bid shall contain technical and commercial offer as per NIT Proforma, indicating acceptance of NIT terms, as per Annexure-I. Acceptance of all technical and commercial terms and conditions given in the format **Annexure I.** (No Deviation certificate and deviation Proforma), duly filled in signed as required. Blank Price Bid Proforma indicating only the rates of taxes and duties applicable, **without rate / price for material**, should be enclosed with the techno-commercial bid Part A.
- 2.7 Any deviation in the above mentioned terms and conditions or conditional offer may render the offer invalid and shall be liable to be rejected, and price bid of such bidders shall not be opened. Price bid of only those bidders shall be opened whose Techno-Commercial offer is found suitable and acceptable. Date of opening of price bid shall be communicated to only those bidders whose Techno-Commercial bid will be accepted.
- 2.8 **Part 'B':** Price Bid Part B should contain only the price duly filled in Price Bid Proforma Annexure II, **without any terms and conditions.** Any terms and conditions, if mentioned in the price bid, shall be ignored and not considered.

3 GENERAL TERMS AND CONDITIONS

- 3.1 BHEL reserves the right to reject the offer and or award the work in full or part without assigning any reason.
- 3.2 Tender should be free from over writing and erasers, additions if any must be attested.
- 3.3 Purchase Order will be subject to general conditions of purchase prevailing in Bharat Heavy Electricals Limited.
- 3.4 Any dispute arising out of this shall be referred to the sole arbitration of Unit Head, BHEL, EMRP, Mumbai OR any other officer nominated by him and his award shall be final and binding on the parties. The venue of the arbitration in all cases shall be Mumbai.
- 3.5 All suits in respect of this NIT shall be in the courts of Mumbai.
