BHEL shall approve all drgs./ docs. in Cat-I in total 3 months' time from the date of P.O."

b) **For Mandatory Spares:-**"Delivery shall be '30 September 2017" or 04 months from the date of manufacturing clearance, whichever is later. Separate dispatch/ manufacturing clearance will be issued for mandatory spares as per SCC.

**10. Payment terms shall be as per GCC (Rev 06).**

**11. Pre-Qualifying Requirement:**

Bidders who fulfil TECHNICAL PRE-QUALIFICATION REQUIREMENT CRITERIA are eligible to participate in this tender. Bidders are requested to provide the details as per "TECHNICAL PRE-QUALIFICATION REQUIREMENT". Bids of only those bidders shall be evaluated who meet the Technical Pre-Qualifying requirements.

12. CIF is not available for this package. Bidders to quote accordingly.

13. Evaluation shall be done on lump-sum basis on overall L1 basis (Total cost to BHEL) including applicable loading (if any).

14. **Reverse Auction:-** Bidders to quote their best competitive prices. BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.
