2. Bidders has to note that this is a conditional Open Tender enquiry. Price bid (Part-II) opening/RA participation of those bidders, who are not registered with BHEL PEM / not approved by Customer (NLC), shall be subjected to following criterion:

a. Approval of bidder by the BHEL

The documentary evidence shall be in the form of Material Receipt, Site Inspection Report, etc from the end user for having received the material by the end user.

3.
