1.1 Price: Price should be quoted strictly as per proforma for price bid, FOR destination basis, vendor has to supply the item at delivery place mentioned in Cl.1.8.

- For bid evaluation, price will be calculated on the basis of landed cost to BHEL as per the price proforma.

1.2 Documents Required: Vendor has to submit the following documents

1.3 Validity of Offer: Three month from the date of technical bid opening.

1.4 Price variation: Price offered should remain firm till the completion & handing over the elevators.

1.5 Delivery Period: Within 5 months from the date of issue of manufacturing clearance / drawing, QAP, datasheet approval whichever is later. Earlier delivery will be preferred. (Drawings / QAP to be submitted within 4 weeks, approval time four weeks and 3 months for manufacturing after drawing/ QAP approval.

- Payment of 80% of basic cost towards design, material supply + mandatory spares, tools and instruments + 100% taxes, duties, transportation will be made within 90 days of submission of bills along with proof of receipt & acceptance of material at site (45 days for MSE vendors) , Kindly furnish Annexure-A9enclosed) duly certified by CA
- Payment of 10 % of the basic order value will be made within 90 days against erection, commissioning and handing over of elevator.
- Balance payment will be within 90 days against submission PBG (performance bank guarantee) for 10% of the basic order value valid for 24 months from the date of handing over the elevator.
- Payment will be made through e-payment only. Vendor should furnish bank details if not submitted earlier.
- No advance payment will be made

1.13 Taxes & Duties: Bidders to clearly specify the taxes and duties applicable on the date of submission of offer. However, any statutory variation in the rates and taxes and duties after the date of submission shall be considered and actual rates applicable at the time of dispatch of material shall be payable at actual against documentary evidence.

- 1.18 Inspection:** BHEL / or its customer / TPI shall inspect the material before dispatch. In the event BHEL / customer waives off inspection, certified test report and results shall be submitted for approval. Vendor has to submit QAP's along with all the relevant Test certificates / Calibration certificates & obtain approval on test report and Material dispatch Clearance Certificate, MDCC / MICC before dispatch of material.
- 1.19 Interpretation of Contract:** In case of two or more than two interpretations or differences in any of the technical specifications or terms and conditions of the contract then the interpretation which is in favour of BHEL shall be final & binding.
- 1.20 Evaluation Criteria:** Price evaluation shall be done on the basis of total landed cost of all elevators with erection & commissioning and inclusive of spares cost.
- 1.21 Applicable Standards:** Items quoted shall be of reputed make meeting EC OR equivalent international standards.
- 1.22 Dispatch Documents:** Dispatch documents shall normally consist of copy of LR, Invoice cum Excise Duty, Gate pass, delivery challan, test certificates/reports, packing list if any and Guarantee/warranty certificate.
- 1.23 Warranty certificate:** Vendor to furnish Warranty certificate for a period of 24 months from the date of delivery or 18 months from the date of commissioning whichever is later.
- 1.24 Submission of QAP:** Please submit the QAP plan as per schedule of the material for further dispatch. Copy of QAP is enclosed.
- 1.25 Risk Purchase:** In case the successful tenderer fails to adhere to the agreed schedule for supply or fails to comply with the terms and conditions of the purchase order. BHEL reserves the right to source such material/component/equipment/system from any other agency at the risk and cost of the successful tenderer. The cost of such purchases along with 25% overhead charges shall be recovered from the bills pending from any other unit of BHEL. In the event of no amount being outstanding from BHEL, successful tenderer shall be liable to pay to BHEL the above amount immediately on demand. The decision regarding applying risk-and purchase clause from BHEL shall be final & binding.
- 1.26 Force Majeure:** The supplier shall not be considered in default if delay occurs due to causes beyond their control such as Acts of God, Natural Calamities, Frost, Fire, flood, Civil War, Civil Commotion, Riot, Government Restrictions.
Only those causes that have duration of more than seven days shall be considered cause of force majeure. Notification to this effect duly certified by local chamber of commerce/statutory authorities with supporting documents shall be given by the supplier to BHEL by registered letter/courier service without loss of time
In the event of delay due to such causes the delivery schedule shall be extended for a length of time equal to the period of Force Majeure or at the option of BHEL the order may be cancelled. Such cancellation would be without any liability whatsoever on the part of BHEL.
In the event of such cancellation the supplier shall refund any amount advanced or paid to the supplier by BHEL and deliver back any material issued to him by BHEL and release facilities, if any provided by BHEL.
- 1.27 PURCHASE:** Preference will be given to CPSUs as per Government Guidelines.
- 1.28 Container:** Material should be supplied in the container to avoid any damage.

1.29 Erection & Commissioning: Boarding & lodging and local transport (to & fro site) arrangement for men along with adequate insurance for their men / material / tools / tackles etc., shall be in vendors' scope.

2.4 Tender No., date and due date of opening should be written on both the covers. These two covers shall then be placed in a large cover and sealed. The Large cover should also have Tender no., Date and Due Date. This should be dropped in the tender box placed at the entrance of our works before due date and time.

2.5 Part 'A' - Techno Commercial Bid: Techno Commercial Bid shall contain technical and commercial offer as per NIT Proforma, indicating acceptance of NIT terms, as per Annexure-I. Acceptance of all technical and commercial terms and conditions given in the format **Annexure I**. (No Deviation certificate and deviation Proforma), duly filled in signed as required. Blank Price Bid Proforma indicating only the rates of taxes and duties applicable, **without rate / price for material**, along with Annexure-II & III should be enclosed with the techno-commercial bid Part A. (Along with Annexures as mentioned in clause 1.2 (b))
