 - **Part-II: Price Bid:** Containing prices, **cost of withdrawal of deviation (As per Annexure-II of GCC Rev 06)**, to be submitted in original, strictly, as per price schedule of BHEL for complete scope of Tender enquiry.
- 3.3 Tenders shall be submitted strictly in accordance with the requirements of the above tender documents. **Deviations (Technical as well as Commercial as per attached sheet), if any, shall be listed out separately in Annexure-II, along with reasons for taking such deviations.**
- 3.4 Standard pre-printed terms & conditions of the tenderers shall not be considered valid.
- 3.5 Bidders who will quote along with their technical collaborator/technology tie-up partner/ JDU partner will not allowed to change/introduce/modify their collaborator/partner after Techno – commercial (Part- I) bid opening. Further, Technical collaboration/ JDU shall be valid till duration of contract between BHEL & GSECL (end customer) and will be further extendable based on BHEL requirements.
In case of bidders submit bid along with technical collaborator/technology tie-up partner/ JDU partner, **clearly** defined scope matrix among them shall be furnished along with the offer for the complete scope.
- 3.6 In case of joint bidding, Consent letter along with **clearly** defined scope matrix is required for acceptance of part order by foreign bidder (principal) and balance by Indian vendor. Total overall responsibility including submission of BG of the contract shall lie with the foreign bidder.
- 3.7 If any bidder has mentioned the term Not Applicable / Not required / Not Quoted in BHEL price format, the same to be substantiated by the bidder. If such item is required to be supplied for system completion in future, same will be supplied free of cost by Vendor.
- 3.8 Purchaser shall be under no obligation to accept the lowest or any other tender and shall be entitled to accept or reject any/all tender(s) in part or full without assigning any reason whatsoever.
- 3.9 Tenderers must enclose the Quality Plan in the prescribed format, for approval. Equipment will be despatched only after Purchaser's/Owner's inspection at the hold points specified in the approved Quality Plan and issue of Material Despatch Clearance Certificate (MDCC).

For Supply (along with commissioning spares):-Ten (10) months from the date of LOA.
Drg./doc. submission schedule shall be as per Annexure VIII of technical specification no. PE-TS-408-164-A008, (enclosed, Pg. no:- 1-3).
Every resubmission shall be within ten (10) days, taking care of all comments of BHEL.

For Mandatory Spares:-

"Delivery shall be '30 September 2017" or 04 months from the date of manufacturing clearance, whichever is later. Separate dispatch/ manufacturing clearance will be issued for mandatory spares as per SCC.

E&C: Five (05) months from the date of availability of front at site.

Site front availability will be reckoned as "Date when BHEL site informs for mobilization of manpower and resources.

3.14 Bidder to note for compliance that this is conditional enquiry and the price bid (Part-II) opening / Reverse Auction is subject to the following:-

- a) Techno-commercial qualification / recommendation of bidder by the BHEL-PEM
- b) Approval of bidder by Customer (M/s GSECL). Same shall be taken up with customer based on the latest credentials/reference list (Preferably not older than 5 years) furnished by bidder. Accordingly bidders are requested to submit the following on or before technical bid Part-1 opening:-

- (i) Company Profile
- (ii) List of projects executed/ on hand for power sectors / Govt. organizations for the subject package.
- (iii) Performance Certificates for satisfactory working of the system /equipment's.
- (iv) Copies of major supply order executed by the vendor.

- 3.17 CIF content:- Not Applicable
- 3.18 Foreign and indigenous bidders participating through open tenders will necessarily have to buy class III DSCs issued by the certifying authorities in India for future tenders. Basic procedure /checklist has been upload on www.bhel.com for participating in future tender enquires through e procurement.
- 3.19 MSE suppliers can avail the intended benefits only if they submit along with the offer, attested copies of either EM II certificate having deemed validity (Five years from the date of issue of acknowledgement in EM II) or valid NSIC certificate or EM II certificate along with attested copy of CA certificate (Format enclosed at Annexure-1 where deemed validity of EM II certificate of five years has expired) applicable for the relevant financial year (latest audited). Date to be reckoned for determining the deemed validity will be the date of bid opening (Part 1 in case of two part bid). Non submission of such documents will lead to consideration of their bid at par with other bidders. No benefit shall be applicable for this enquiry if any deficiency in the above required documents are not submitted before price bid opening. If the tender is to be submitted thorough e-procurement portal, then the above required documents are to be uploaded on the portal. Documents should be notarized or attested by a Gazetted Officer.

- 3.21 Indigenous bidders needs to indicate the freight charges in percentage of total Ex-works in unpriced format.
- 3.22 Bank guarantee (BG's) should be in favour of BHEL PS-WR. Bidders will be required to submit the BG's to executing agency i.e. BHEL-PS-WR (Power Sector – Western Region)
- 3.23 All the tender documents shall automatically become a part of the Order/Contract after its finalization.
- 3.24 The bidder along with its associate/collaborators/sub vendor/subcontractors/sub vendors/consultants/ service providers shall strictly adhere to BHEL fraud Prevention Policy displayed on BHEL website www.bhel.com and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice. 
