9. Delivery Schedule:

For Supply (along with commissioning spares):- Eight (08) months from the date of drawing/docs approval in CAT – 1 issued by BHEL/ Customer. This is subject to bidder's 1st submission of drawing/docs within two weeks from the date of P.O. Vendor to re-submit drgs/documents within 7 days only taking care of all the comments of BHEL. BHEL shall approve/ comment on drgs./ docs. within 10 days. BHEL/Customer shall approve all drgs. / docs. in Cat-I in total 2 months time from the date of PO.

For Mandatory Spares:-

"Delivery shall be '30 September 2017" or 04 months from the date of manufacturing clearance, whichever is later. Separate dispatch/ manufacturing clearance will be issued for mandatory spares as per SCC.

10. Pre-Qualifying Requirement :- Bidders who fulfil TECHNICAL & FINANCIAL PRE-QUALIFICATION REQUIREMENT CRITERIA are eligible to participate in this tender.

Bidders are requested to provide the details as per "TECHNICAL & FINANCIAL PRE-QUALIFICATION REQUIREMENT". Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.

11. CIF is available for this package. Bidders to quote accordingly.

12. Evaluation shall be done on lump-sum basis on overall L1 basis (Total cost to BHEL)

13. Reverse Auction:- Bidders to quote their best competitive prices. BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit online sealed bid in the Reverse Auction. Non-submission of online sealed bid by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.

Terms & conditions of Reverse Auction shall be as per Annexure-I. (Enclosed).

14. During price evaluation in case of foreign currency bids, exchange rate (TT selling rate of State Bank of India) as on date of tender opening (Part-I bid in case of two part bid) shall be considered.
