## PRE QUALIFICATION

- 4 Labour licence (Central / State Government) before commencement of work.
- 5 **PAN No.** ( in case not available, proof of having applied with acknowledgement from concern authorities)
6. **APGST** (in case not available, proof of having applied with acknowledgement from concern authorities) (**It is required to furnish VAT registration certificate issued by Commissioner, Commercial taxes, AP Govt, in respect of all works costing more than Rs. 5.00 lakhs each.**)
7. **Service Tax registration no:** in case not available, proof of having applied with acknowledgement from concern authorities Before commencement of work.
8. Period of completion shall be as mentioned in NIT.
9. Penalty: 0.50 % of the gross value of work will be levied for every weeks delay by the agency subject to a maximum of 10 % value of the work.
