6. **APGST** (in case not available, proof of having applied with acknowledgement from concern authorities) (**It is required to furnish VAT registration certificate issued by Commissioner, Commercial taxes, AP Govt, in respect of all works costing more than Rs. 5.00 lakhs each).**
