3. Tender documents may be obtained from the above office by submitting an application and cost of tender documents by Demand Draft (in favour of Bharat Heavy Electrical Ltd, Payable at Industrial areas Jagdishpur.
4. Bidders may also download the tender documents from websites www.bhel.com at "Tender Notifications" and use the documents for submission of tender. In such cases, the cost of tender documents shall have to be paid by Demand Draft at the time of submission of offer.
5. BHEL takes no responsibility for any delay / loss of documents or correspondence sent by courier or post.

6. The offer is to be submitted in two separate envelopes for Techno-commercial bid and Price Bid sealed envelope properly marked .The tender shall be submitted in Two Part Bid.
7. Offers should be strictly in accordance with the tender specifications & General Instructions to the Tenderer enclosed herewith.
8. Only Tenderers who have previous experience in the work of the nature and description detailed in this tender specification are expected to quote for this work. Offer from Tenderer who do not have proven and established experience in the field as per Annexure NIT-I, will not be considered.
9. Tenderers are advised to go through the project scope of work, site location etc and get them fully acquainted with the work place and prevailing working conditions before submitting the Offer.
10. The Tenderer should accept all terms & conditions of the tender unconditionally. In case the Tenderer wants to deviate from the tender conditions, such deviations shall be clearly specified in the offer. If no deviations are given in the offer, it will be assumed that the Tenderer accepts all terms and conditions of the tender.
11. Offers with deviations from terms and conditions of this tender are likely to be rejected.
12. The Tenderers are required to quote for the complete scope of work with rates for all the items & no column should be left blank.
13. Order will be placed on a single bidder for the complete scope of work.
14. **Time Duration:**
 - a) The contractor is required to commence the work within 7 (seven) days from the date of issue of letter of intent unless BHEL decides any other date for the same.
 - b) Entire work as shall be completed within 01 (one) months from the date of start. Contractor is required to commence the work within 07 days after award of works as directed by engineer-in-charge.
15. Penalty will be levied by BHEL as per relevant clauses of the Tender on account of delay, violation of contract conditions and non-performance of the Contractor.
16. All documents submitted by the Tenderer in his offer shall be accompanied with a covering letter giving index interlinking all the documents.
17. BHEL reserves the right to accept or reject any of the bid / all bids with or without deviation or cancel / withdraw the invitation for bid without assigning any reason whatsoever and in such case no bidder shall have any claim arising out of such action by BHEL.

18. BHEL reserves the right to reject the tender from any bidder on the basis of unsatisfactory performance of the bidder in any ongoing job or any similar job of BHEL in last five years, or if the bidder has been kept under hold/ blacklisted by BHEL.
19. BHEL reserves the right to go for Reverse Auction (on line bidding on Internet) instead of opening the submitted sealed paper price bid as per Cl 35 of part-B of GCC. Any bidders who do not accept the processing of price bids through Reverse Auction as per point-18 of Annex-E (checklist) of GCC are liable for rejection.
20. BHEL's General Conditions of Contract (GCC) and Technical Specifications for works contract shall be considered as a part of this tender which is available in the office of undersigned. Bidders may go through the document before quoting for the work.
21. In case more than one contractor quotes the L1 (lowest & technically accepted) rates, the work may be awarded through draw of lottery.
22. **Scope of Works:** Scope of work shall broadly cover the following works:
 - a) Repairing of Tile flooring in FP admin building.
 - b) Repairing of CC Flooring in Blanking line Machine Area.
 - c) Providing saucer drainage for cooling tower.
 - d) Moreover scope of work shall be as per BOQ.
23. **Security Deposit:**
 - i. Contractor shall deposit 10% of contract value as security deposit before start of work failing which BHEL shall release the bills only after deduction of the SD from RA Bills as per GCC.
 - ii. 50% SD shall be released after Completion of the work however balance 50%SD shall be released after completion of guarantee period.
24. **Guarantee:** The works contracted by the contractor shall be Guaranteed for a period of 12 (twelve) months from taking over by BHEL. During this period the Contractor shall attend to all matters relating to the Contract work as required by BHEL.
25. **Payment Terms:**
 - Full & final payment shall be made on the basis of actual quantity executed at site during the month after completion of works in all respect.
 - From the amount payable, recoveries such as advances, security deposit, taxes etc. would be made.
26. **Variation in scope of work/Deviation Limit:**

BHEL reserves the right to add or delete items of scope of work depending upon the final requirement. For such addition or deletion the Contract price shall be adjusted based on the quoted unit price. Such variation in item quantities may vary upto any extent however total contract value is not expected to be more than $\pm 15\%$. The price quoted by the Contractor shall be valid for such variation. Variation beyond the above limit can be executed on mutually agreed rates.
27. The Tenderers are required to quote for the complete scope of the work with rates for all the items & no column should be left blank. Tenders for the part of the work or incomplete in any respect are liable to be rejected.

28. **Penalty for Delay:** If the Work is not completed within the specified period and any extension thereof, the Contractor shall be liable to pay penalty for delay in completion of work @ 0.5% of the total Contract value for every week of delay or part thereof, subjected to a maximum of 10% of the Contract value without BHEL being required to establish and prove the actual loss/damage suffered by BHEL on account of such delay.
29. All documents submitted by the Tenderer in his offer shall be accompanied with a covering letter giving Index interlinking all the documents.
30. Tenderer shall follow and fulfil all desired contractual/technical formalities like FQP etc. as per BHEL's guidelines.
31. BHEL reserves the right to accept or reject any of the bid/all bids with or without deviation or cancel/withdraw the invitation for bid without assigning any reason whatsoever and in such case no bidder shall have any claim arising out of such action by BHEL.
32. BHEL's GCC, SCC, Technical Specifications for works contract shall be applicable in the above tender which is available in the office of undersigned. Interested bidders may collect the same from the office of undersigned.

A. QUALIFICATION REQUIREMENTS

1. Bidder should have completed the Civil Works like construction of industrial plant and office buildings and similar works in last seven years ending on 30.11.2015. Values of such work done should be as under:
 - a) One job of value of Rs 1.38 Lakh or above, or
 - b) Two jobs of value of Rs 0.86 Lakh or above each, or
 - c) Three jobs of value of Rs 0.69 Lakh or above each

And

2. The Tenderer shall be financially sound and should have achieved an average annual financial turnover of minimum Rs. 0.52 Lakh per year over three consecutive financial years ending on 31.03.2015

B. DOCUMENTS REQUIRED

The Tenderer shall submit documents in respect of possessing Qualifying requirements as under duly certified and stamped by his authorized signatory:

- a) List of Jobs undertaken with details and value meeting the above conditions.
- b) Copies of work orders issued by customers.
- c) Copies of completion certificates issued by customers.
- d) Declaration not guilty a court of law as per affidavit 'A'.
- e) Certified self for not black listed as per affidavit 'B'.

C. Checklist/ Minimum qualification criteria

MANDATORY DOCUMENTS

The following documents must be enclosed along with the Techno Commercial Bid, Failing which the tender shall be summarily rejected.

1. PAN no. and copy of PAN card
2. Trade Tax registration (TIN no.)
3. Details of ownership of firm (whether proprietary, partnership or Limited Company).In case of partnership firm and Limited Company.
4. Self Certificate declaring that the contractor shall abide by all statutory and legal Requirements of appropriate government.

OTHER DOCUMENTS
