A. Scope of Work: Scope of work includes:

1.0 Maintenance of A/c & water coolers

3.0 Shifting of Equipment

3.1 During the period of contract the W/C & A/C(approx.406 Nos) may be required to be shifted from one location to other within BHEL factory premises as well as in BHEL, as and when required.

3.2 Contractor to make own arrangement for shifting the A/C or W/C out side or in side the factory, mode of transportation may be provided by BHEL to the party, if available.

4.0 Maintenance of all type of panel A/c & chillers installed in various machines in factory premises.

5.0 Installation of all type of Air Conditioners, Deep freezers, fridges and water coolers installed in factory & Township premises.

9.0 Idle Hour of unit:- All daily breakdowns will be attended by the contractor on the same day of breakdown and no pending breakdown will be allowed to be carried over next day without sufficient reasons and this should be brought to the notice of AC section in charge before closing of the day. All the major breakdown will be reported by the contractor to the in charge of section and completed at the earliest.

10.0 Requirement of Man-Power:- Contractor is required to maintain sufficient experienced (Technician & helper) staff to carryout the subject work during total contract period.

11.0 Period of Contract:-The period of contract will be for Twelve months from the date of award the work order.

12.0 Cancellation of contract in full or part:- Contract shall be cancelled in full or part if the contractor:

- (a) At any time makes defaults in proceeding with the work with due negligence and continuous to do so after a notice in writing or 7 days from the AGM (WE&S), BHEL, Jhansi
- (b) Commits defaults in complying with any if the terms and conditions of the contract.

13.0 Terms of Payment:-

- (a) Payment will be made every month on submission of actual work done during the month, satisfactory performance report from the in charge along with the bills duly verified by in charge maintenance.
- (b) Income tax will be deducted from the each bill. This will be as per guideline of Gov. Of India. At present 2.00 % income tax will be deducted.
- (c) Service tax will be paid; this will be as per Guideline of Gov. of India. At present the rate of service tax is 12.36 %. Contractor should be submitted challan copy of service tax deposit.

14.0 Urgent Work:- The contractor shall have to comply with the priority fixed by services in charge or for taking urgent repair work.

15.0 Facilities and Free Issue:-

- (a) Water, Electricity, Compressed Air, Oxygen and Acetylene welding facilities and welding/Brazing rod will be provided by BHEL free of cost. However, No claims will be admissible if the above facilities are not provided due to any reason what so ever both within factory premises and outside.

- 17.1 All the break down shall be attended from 7.00 Hrs to 16 Hrs incase of additional work staff will be detained after 16 Hrs.
- 17.2 Staff may be also detained on Sunday/holiday or during night hrs if required.
- 17.3 Supply points of A/c and water coolers to be maintained by the party however all required material shall be provided by BHEL.
- 17.4 No foreign/used/unused/scrapped/broken parts shall be left on the crane gantry/bridge to avoid falling of the same and causing accidents.
- 17.5 All used/worn-out/scrapped/replaced spares/parts shall remain the property of BHEL, Jhansi. These items shall be return to WE&S store.
- 17.6 BHEL, Jhansi shall not be liable for any compensation what so ever in the event of accident/injury to the persons employed by the contractor, however, First Aid facility shall be rendered free of cost.
- 17.7 Utmost care should be taken by the contractor to repair the A/c and water coolers etc in proper way & with Quality workman ship so as to satisfy the safety requirements as per Factory Act, 1948 Section 19 & U.P. Factories Rules 1950 Rule 55-A & subsequent amendments enforced from time to time.

- Above tender is in two Bid System (Techno Commercial Bid & Price/ Rate Bid).
1. The tender is to be processed in two parts viz. 1) Techno Commercial bid 2) and price/rate bid. The Technical Bid Application (Annexure - I) and its enclosures (along with the Contractor's Obligations, General Terms & Conditions and copies of qualifying requirements) must be submitted in one sealed envelope superscripted as "Tender for Maintenance of Air Conditioners & Water coolers in BHEL-Jhansi factory & Township(Work Contract) . TECHNOCOMMERCIAL bid". EMD/Cost of Tender Document or Documents required as per qualifying requirements must be enclosed. TENDER EVALUATION CRITERIA

The evaluation of the Tender will be carried out as follows:

1. BHEL officials may visit the bidders' office & their client's place to evaluate the capability and assess the performance.
2. Capability of the Contractor will be assessed on the basis of employees including Supervisors on their rolls, machinery, equipments in its possession, previous track record, experience in other organizations, etc.
3. Price Bids will be opened or participation in Reverse auction will be allowed to only Techno-Commercially accepted bidders.
4. The contractor shall be awarded the work on overall L-1 basis if otherwise not specified in the tender document.
5. In case of tie between two or more than two bidders for L1 price . Bids shall be called for discount on price offered in sealed envelope from all the L1 bidders. In case of discrepancy in words and figures offered in price bid the decision shall be taken based on annexure "V"

CONTRACTOR'S OBLIGATIONS

A) CONTRACTUAL:-

Towards selection, control and supervision of employees:-

1. Contractor shall decide the number of employees to be deployed for execution of the work awarded to him and he or his authorized representative will be solely entitled to instruct such about the manner of carrying out the work as per the prescribed specifications and quality plan.
2. Contractor shall supervise the work allotted to him and to be carried out by his employees.
3. Contractor will ensure that the job is executed through his employees on his rolls and under no circumstances the contractor will deploy any casual employee to carry out the job nor shall sub-contract the job without prior written permission.
4. **Age of workers:** The contractor shall not employ any person who has not completed his 18 years. Also age of worker deployed should not exceed 60 years.
5. Contractor to ensure that the employees deployed in the premises of BHEL are physically and mentally fit and do not have any criminal record. Such employees should possess requisite skill, proficiency, qualification, experience etc. acceptable to concerned department.
6. **Discipline:** The Contractor shall be responsible for the discipline of his own employees deployed under the contract. In case of any loss to the BHEL Jhansi on account of indiscipline of employee then such loss shall be assessed and recovered from the running bills of the contractor or from the security deposit.
7. The contractor, on advice of authorized BHEL official, shall immediately remove any person employed by him, who may in the opinion of such authorized BHEL official is involved in misconduct. Such person shall not be re-employed by the contractor without prior permission.
8. Contractor will keep watch on his employees and he will be liable for any pilferage / loss to BHEL due to acts of omission and commission by his employees. Similarly, liability for any compensation to outsiders on account of any act of omission and commission by the employees deployed by the contractor shall lie exclusively with him.
9. Contractor to ensure that all precautions are taken for safety of his employees and equipments.
10. **Record Keeping:** Contractor to maintain appropriate records of his employees deployed to carry out the job(s). Contractor shall maintain neatly written, complete and legible registers, records, reports and returns for inspection by various authorities at short notice.

11. **Uniform:** The contractor shall be responsible to provide to his workers uniform and safety gears such as shoes, helmet and PPE . The uniform should be dark blue trousers and light blue shirt for males and dark blue trousers/salwar and light blue kurta/ kameez/top for female. The uniform should have logo of the contractor's firm/ company which shall be affixed by the contract labor on the left side of his pocket. The uniform shall be kept in neat, tidy and wearable condition. The stitching and logo charges should be borne by the contractor. Contractor shall ensure that the employees are in neat and tidy uniform and safety gear on duty. Penalty of 5% of monthly bill may be imposed if the workers are not found in prescribed uniform and safety gears.
 12. **Bus Pass :** Contractor may apply for providing bus pass facility to his workmen. BHEL will consider such applications based on merits and availability of seats. Contractor would be responsible for depositing bus pass charges and penalties (if applied) of his/her workmen/staff etc. BHEL would have the right to deduct/recover the same in case of default by the contractor/supplier.
 13. In the event of termination of contract for any reason whatsoever, the contractor shall withdraw all his employees from the establishment of BHEL. In case contractor decides to terminate services of his employees, he should settle all terminal dues required.
 14. **Tools, tackles and materials :** Contractor shall provide to his employees all tools, tackles, material, equipments as specified in contract and maintain the same to carry out the job under the contract at his risk and cost. BHEL shall not have any liability for these tools, tackles, equipments or material.
- B. Towards statutory liability**
1. As mentioned in the terms and conditions enclosed as Annexure 'G' of this contract.
 2. Contractor shall indemnify BHEL against all claims by statutory authorities and losses under various Labour Laws, statutes or any civil or criminal law in connection with employees deployed by him.
 3. Contractor shall be responsible for making payment of wages before expiry of 7 days from the last day of wage period (wage period shall be from 1st day of the month to the last date of the month) and to ensure disbursement of wages in the presence of the authorities representative of contract operating division who shall record under his signature at the end of entries in the Register of wages.

1. Security Deposit

1.1 Depending on value of contract awarded the amount of Performance Security Deposit shall be as following:

Upto Rs 10 Lakhs	10%
Above Rs 10 Lakhs & upto Rs 50 Lakhs	Rs.1.0 Lakh + 7.5% of the amount exceeding Rs 10 Lakhs
Above 50 Lakhs	Rs. 4.0 Lakhs + 5% of the amount exceeding Rs. 50 Lakhs.

1.2 The bidder shall submit the 'Performance Security Deposit' within 30 days of awarding of contract/ issue of Letter of Intent as following:-
