**II. PRE - QUALIFICATION CRITERIA:**

1. Earnest Money Deposit (EMD) mentioned in first page
2. The Bidder should have valid Income Tax PAN Card. Documentary proofs / Xerox copies are to be enclosed.
3. The Bidder should have valid Service Tax registration number (If applicable) otherwise has to submit a Self-Declaration of "Non Applicability of Service Tax" (Format enclosed with this tender document) on their Company's Letter Head.
4. The Agency could be a Proprietorship/ Partnership Firm/LLP/One person Company/Private Limited Company/Public Limited Company/Trust/Society in this line of service / business - documentary proof / Xerox copy to be enclosed.
5. Average annual Turnover for the last three financial years ending 2015 or 2016 should be min. Rs.9.0Lakhs. Financial statements comprising audited balance sheet, profit and loss accounts and notes to accounts if any or certified turnover from chartered accountant for last three financial years ending 31.03.2015 or 31.03.2016 should be submitted.
6. The bidder should have horticulture experience in industry/ institution for a period of minimum 3 years over the last 10 years as on 31.05.2016. Work order copy and corresponding work completion / Execution Certificate should be submitted as proof.

**1. Earth wok excavation in ordinary soil:**

Earth wok excavation in ordinary soil including removal and stacking of serviceable materials and then disposing of by spreading and neatly levelling with in a lead of 50 m and making up the trenched area to proper levels by filling with earth mixed with sludge or manure and flooding trench with water before and after filling (excluding cost of earth, sludge, manure, mixing and filling). All as per instructions of Engineer in charge.

**2. Digging pits in ordinary soil:**

Digging pits in ordinary soil and refilling the same with the excavated earth mixed with manure or sludge in the ratio of 2:1 by volume (2 parts of stacked volume of earth<sup>14</sup> after reduction by 20% for voids: 1 part of stacked volume of manure after reduction by 8% for voids) flooding with water, dressing including removal of rubbish and surplus earth, if any with all leads and lifts (cost of manure, sludge or extra good earth, mixing and filling will be paid separately). All as per the instructions of Engineer in charge. Pit size 60cm dia and 60cm deep.

Uprooting rank vegetation and weeds:**

*Uprooting rank vegetation and weeds by digging the area to a depth of 60 cm removing all weeds and other growth with roots by forking repeatedly, breaking clods, rough dressing, flooding with water, uprooting fresh growths after 10 to 15 days and then fine dressing for planting new grass (for lawn), including disposal of all rubbish with all leads and lifts. All as per instructions of Engineer incharge*

**4. Supply and Stacking at site - River sand :**

*Supply and Stacking at site (at BHEL/ PPPU factory) - River sand (No Voids) as per instructions of Engineer incharge. Rate includes loading, transportation and unloading charges*

**5. Supply and Stacking at site - Red Earth:**

*Supply and Stacking at site (at BHEL/ PPPU factory) - Red Earth (No Voids) as per the instructions of Engineer incharge. Rate includes loading, transportation and unloading charges*

**6. Supply and Stacking at site – Earth:**

*Supply and Stacking at site (at BHEL/ PPPU factory) - Earth (will be reduced by 20% for voids) as per instructions of Engineer incharge. Rate includes loading, transportation and unloading charges.*

**7. Supply and Stacking at site - Cattle Manure:**

*Supply and Stacking at site (at BHEL/ PPPU factory) - Cattle Manure (will be reduced by 8% for voids) as per instructions of Engineer incharge. Rate includes loading, transportation and unloading charges.*

**8. Conveyance of earth :**

*Conveyance of earth in and around the factory within a radius of 2kms using contractors own lorry including loading, conveying, unloading as per the instructions of Engineer in charge. The rate shall be inclusive of all labor, tools, equipment's, fuel and hire charges for lorry.*

**9. Filling mixture of earth and sludge:**

Maintaining the shrub plants available:**

*Maintaining the shrub plants available at various locations which covers watering once in two days, weeding, mulching the top soil to a depth of 15 cm once in a month, making basin to proper size, manuring, cutting the area etc., complete. Replanting is also to be done whenever necessary. All as per instructions of Engineer incharge. Rate includes all labour, tools, hose pipes, water carts, all incidentals etc., complete. Rate is for maintaining one plant per month.*

**14. Maintaining the hedges:**

*Maintaining the hedges (up to a height of 1.50 m) available at various locations in BHEL. Maintenance covers watering once in two days, weeding, mulching the top soil to a depth of 15 cm once in a month, making basin along the hedges, manuring and cutting, pruning, trimming the hedges once in a month, cleaning the areas, disposing off all wastes, cut branches, leaves etc. in the nearby areas within a lead of 100 metre etc. complete. Replanting is also to be done as and when necessary. All as per instructions of Engineer-in-charge. Rate includes all labour, tools, hose pipes, water carts, all incidentals etc. Complete. Rate is for maintaining one metre hedge per month.*

**15. Maintaining and safeguarding the lawns:**

*Maintaining and safeguarding the lawns including flower beds available at various locations inside BHEL. Maintenance covers watering once in two days, periodical weeding, mowing, scraping, raking, replacing flower beds, mulching the top soil and forming basins etc.all once in a month, manuring, cleaning the areas, disposing off all wastes, dried leaves etc. in the nearby areas within a lead of 100 metre etc. Complete. Re-lawn is also to be done as and when necessary. All as per instructions of Engineer-in-charge. Rate includes all labour, tools, hose pipes, water carts, all incidentals etc.complete. Rate is for maintaining one sqm per month*

**16. Maintenance and protection of avenue tree:**

*Maintenance and protection of avenue tree plants available at various locations inside BHEL. Maintenance covers watering once in two days, protecting the plants periodical weeding, maintaining the area free from other vegetation growth, mulching the top soil and forming basin, manuring, cleaning the area etc. complete. ### 20. Ploughing the existing ground:

*Ploughing the existing ground to a depth of 15 cm to 25 cm manually or mechanically as per the instructions of Engineer incharge.*

### 21. Labour charges for mixing the earth:

*Labour charges for mixing the earth, red earth, sand, manure, coconut waste etc. thoroughly to the required proportion and carrying the same and filling it in the excavated pits/ areas at various locations with all leads and lifts. Rate excludes cost of materials.*

### 22. Hire charges for engaging JCB:

*Hire charges for engaging earth moving machinery (pockline) to attend to channeling works at river bed, pipe line burst works, cleaning the areas including uprooting thorny plants/heavy jungles/trees etc. of all heights and leveling the areas thereafter including all debris etc., all as per instructions of Engineer-in-charge. Rate includes hire, fuel, operation charges, to and fro charges for machinery, all labour and all other incidentals etc., complete.*

### 23. Clearing jungle including vegetation:

*Clearing jungle including uprooting of rank vegetation, grass, brushwood, trees and saplings of girth upto 30 cm measured at a height of 1 metre above ground level and removal of rubbish upto a distance of 50 metre.*

### 24. Supply of well burnt and baked flower pot:

*Supply of well burnt and baked clay flower pots of height at least 280mm or more, top inner diameter 280mm or more and bottom inner diameter 130mm or more. The pots should be free from any defects / cracks. The pots should be supplied and stacked at PPPU, BHEL, Thirumayam. The rate includes cost of pots, transportation, handling and stacking.*

## IV. WORK SPECIFIC TERMS AND CONDITIONS:

- The Scope of works includes formation of Lawns & development of garden and maintenance inside Power Plant Piping Unit (PPPU), BHEL, Thirumayam.*
- The contractor should make all efforts to complete the assigned work in time i.e. within completion period of 18 months.*
- The tenderers are advised to visit the BHEL/PPPU, Thirumayam and get themselves acquainted with the site conditions before submitting the bids.*
- Contract Value is only approximate and liable for variation without entitling the tenderer to any compensation, till the total value of contract vary by more than 20% (Twenty percentages).*
- The item rate offered is for finished item of works and shall provide for the complete cost towards fuel, tools, tackles, plant & machinery, temporary works, labour, materials, levies, taxes, transport, lay-out, repairs, rectifications, maintenance till handing over, supervision, labour colonies, establishment, services, roads, revenue expenses, overheads, profits & all other incidentals etc., complete. However if the service tax is applicable for this contract work and free issue materials, the same will be reimbursed on production of valid document proof for having paid service tax by the contractor.*
- Some changes are likely in the quantities furnished as well as in the layout, design and specifications of the work. The rates quoted shall be deemed to be inclusive of all such contingencies.*
- Usually, working hours are limited to day time only. In emergency cases to carryout works during nights, it may be done so with the specific prior permission of BHEL. In such case, it is to be carried out in the presence of BHEL officials or their authorized persons.*
- The work shall be carried out as per Civil Engineering Department Work & Safety procedure, and as per the instructions of Engineer-in-charge.*

9. For any item of work not covered in Scope of work/Price Bid, the rate will be arrived at based on the conditions given in BHEL General Conditions of Contract in force.
10. The contractor should bring the earth moving machineries like Poclairn, JCB etc., as and when required for the work without any delay. Also required tools & Plants / equipment shall be made available always at site for the works.
11. The contractor has to arrange sufficient number of vehicles to collect & transport the surplus earth, horticulture waste etc., generated at site. Otherwise BHEL would clear the waste at the contractor's risk and cost.
12. The contractor has to execute any item of work irrespective of the quantity available in the tender without any reservation till the contract value does not vary more than 20%.
13. Statement of completed works with detailed measurements shall be submitted by the contractor in the first week of succeeding month for processing bill.
14. The decision of Engineer-in-charge shall be final and binding on the contractor regarding clarification of items in this tender schedule.
15. The contractor shall follow norms of BHEL security system for movement of men & materials within the complex.
16. Separate non-technical persons should be engaged for arranging daily gate passes for labours and vehicles entry in all the gates of Factory Complex.
17. Contractor's materials and tools & plants shall have to be brought inside factory with proper invoice / voucher and make necessary entry in the security gate. They should maintain proper record for tools and plants, materials, etc., brought inside the factory complex.
18. The contractor should extend full co-operation to the other contractors who may be doing other works in the same areas to enable them to execute their portions of work without any delay or difficulty.
19. STP treated Water and electricity will be provided at one point by BHEL free of cost.
20. Normally work will be carried out on all days except Sundays & public holidays. However in case of urgency, the contractor has to work on Sundays also.
21. Tools, accessories, pumps, vehicles and water carts shall be arranged and maintained by the contractor at his own cost for this work.
22. Minimum of 8 persons and one supervisor should be engaged every day for regular maintenance activities like Maintenance of shrubs, hedges, lawns, trees, potted plants etc., Maintenance includes application of pesticides/ insecticides as and when necessary and to keep all the plants, trees, lawns healthy and free from pests. The maintenance charges include cost of pesticide.
23. For all other activities the contractor has to deploy extra manpower. However, more number of labours should be deployed when required by BHEL in case of urgent work to the entire satisfaction of BHEL.
24. The Contractor's personnel should wear PPE & uniform inside BHEL complex.
25. The entire horticulture work has to be carried out inside BHEL/PPPU factory, Thirumayam.

### V. PENALTY:

1. Non-performance of any of the activities as per the quality norms specified in the tender/contract will attract penalty.
2. Non-performance of any of the daily activities/ allotted work will lead to recovery being made on pro rata basis + 15% BHEL administrative charges for the incomplete works from the contractor bills as penalty.

### 01. RATE:

- a) Unit rates should be quoted in figures as well as in words with reference to the item shown in the attached schedule. These rates shall be for the specified work in site.
- b) Rate for the item of the tender schedule should be quoted in Rupees and paise only as per the Work / Rate schedule both in figures and words. In case any difference in rates quoted to figures and in words, the rate quoted in words will be taken as the tendered rate.
- c) Rates should be quoted as per the **Price bid format**. Rates quoted in any other form will not be accepted and will be rejected.
- d) Contractor has to ensure that all statutory payment as per Minimum Wages Act / Payment of Wages Act etc. and BHEL additional monthly payment (as indicated in Welfare Conditions) to be taken care of while quoting. No claim in respect of payment to workmen will be entertained at a later stage. It will be responsibility of contractor to comply with statutory payments to workmen in this regard.
- e) If, in the price structure quoted for the required goods services works, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
- f) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- g) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject of (e) and (f) above.
- h) If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.
- i) **The rates quoted should be exclusive of service tax, SBC & Krishi kalyan cess and inclusive of any other taxes & duties levied or to be levied both by Central and State Government Authorities. Such levies should be borne by the Contractor.**
- j) All entries in the tender documents should be made in one ink. Erasure and over-writing are not permitted. All cancellations and insertions should be duly signed by the Tenderer concerned.
- k) Before tendering, the tenderers are advised to inspect the site of work and its environments and be well acquainted with the actual working and other relevant conditions, position of materials and labour.
- l) The rates quoted in the tender shall remain valid initially for a period of at least "THREE MONTHS" from the date of opening of Technical bid. After successful award of contract, these rates shall be firm throughout the contract period.
- m) Service Tax Payment will be reimbursed as per statutory provisions, subject to production of proof of payment / remittances.

17. All excavations must be barricaded and red lamps must be provided.
18. All electrical connections must be properly earthed.
19. No work should be taken up for execution inside shop floor, without obtaining necessary work permit.
20. Providing helmet, safety belt, etc., for high level work and sufficient number of Industrial Safety nets at appropriate level to safeguard the persons working at high level particularly in trusses, girders, roofing etc., of industrial and high roof buildings.
21. The contractor should maintain a register regarding the driver license particulars.
22. All personal protective equipment conform with standard specification as per the details given in the code of conduct.

**32. SAFETY PRECAUTIONS TO BE OBSERVED WHILE TRANSPORTING MATERIALS**
