	QUALIFYING CRITERIA	
1.	The BIDDER / VENDOR (OEM) shall have a minimum of FIVE Years of Continuous Experience in the Design, Fabrication & Supply of "FIRE JEEP ENGINES". Vendor may indicate the actual no. of years of experience in the field.	
2.	The Bidder/Vendor (OEMs), supplied and commissioned at least THREE FIRE JEEP ENGINES mounted with the following in the past five years are eligible to quote. a. Water tank capacity of 700 liters or more.	
3.	The supplied Fire Jeep Engine should be working satisfactorily for at least one year after its commissioning (as on Original date of opening of this Tender). Performance Certificate: - Vendor has to submit at least Two Performance Certificates from customers who are Central Govt. /State Govt./PSU/MNCs for satisfactory performance of supplied Fire Jeep Engines. For Performance certificate, a suggestive format is provided.	
4.	BHEL reserves the right to verify the information provided by the Vendor for the referred Fire Jeep Engines at their referred customer's works. It shall be the responsibility of the vendor to facilitate the visit of BHEL's team at their referred customer works. The Travel, Boarding and Lodging expenses for BHEL Personnel shall be borne by BHEL. In case the information provided by vendor is found to be false/ incorrect, the offer shall be rejected.	
5.	The vendor shall have In-house Facilities for conducting hydrostatic tests and other performance related tests for Fir Jeep Engine.	
6.	Specify details of Fire Jeep Engines supplied to BHEL units, if any.	
7.	Details of Service –After – Sales set-up in India including the Address of Agents/Service centers in India.	
8.	The equipment shall be delivered within 6 months from the date of placement of PO.	
9.	Product catalogues to be provided with the offer.
