

SPECIAL TERMS AND CONDITIONS

1. The offer has to be submitted in **SINGLE PART BID** on or before the due date. In case the due date will be a closed holiday then the tender will be opened on next working day.
2. Please quote the price "**on FOR destination**" basis inclusive of packing & Forwarding, Freight and insurance.
3. Rates quoted shall be inclusive of all taxes, duties, on FOR Destination – Door delivery basis. Supplier should furnish **ED details** separately in their offer / invoice, for BHEL to avail CENVAT benefits. We will not furnish any 'C' Form.
4. 100% Payment will be released within 30 days, on receipt of materials against **SRV** issued by the consignee.
5. **DELIVERY / TEST CERTIFICATES / INSPECTION: DELIVERY / TEST CERTIFICATES / INSPECTION:** The supplier is also requested to dispatch the material after completion of Inspection and after getting dispatch clearance from BHEL. However the Site may please be contacted for their exact requirement and dispatches shall be effected accordingly.
6. Nitrogen gas is to be supplied in tanker. Tankers will be retained at site for a period of 4-5 days. Tanker retention charges on per day basis is to be included in the offer.
7. **Evaluation will be based on the total of the price of Nitrogen gas and tanker retention charges for 4 days.**
At the time of delivery, any change +/- in the number of days of tanker retention shall be operated based on charges mentioned in the offer on per day basis.
8. Legal compliances such as factory licenses, consent to operate from state pollution control boards (SPCBs) & Hazardous waste authorization from SPCBs (if applicable & relevant) shall be furnished along with the offer.
9. Please refer to the instructions to Tenders regarding Terms & Conditions as applicable to this Enquiry, which is enclosed.
10. Please seek all the clarifications, if any, before quoting and submit a "**NO DEVIATION CERTIFICATE**", agreeing to all terms and conditions
11. Supplier has to submit **THE MATERIAL SAFETY DATA SHEET** for Transportation & Handling the above chemicals along with the offer.
12. The offer validity should be **90 days** from the date of opening of Tender.
13. Vendors should transport the chemicals through reliable transporters who have proven facilities for safely transporting such chemicals. **(Emergency Management Card should accompany during supplies).**

- C) Valid EM II certificate along with attested copy of CA certificate as per prescribed format Annexure - 1 applicable for the relevant financial year (latest audited),where the deemed validity of EM II is over

MSE suppliers can avail the intended benefits only if they submit along with offer, attested copies of either EM II certificate having deemed validity (Two years from the date of issue of acknowledgement in EM-II) or valid NSIC certificate or EM II certificate along with CA certificate (Format enclosed as per Annexure - 1) applicable for the year, certifying quantum of investment in plant and machinery within the permissible limit as per the act for relevant status (Micro or small) where the deemed validity of EM II is over. Date to be reckoned for determining the deemed validity will be the last date of technical bid submission. Non submission of such documents will lead to consideration of their bids at par with other bidders and MSE status of such suppliers shall be shifted to Non MSE supplier till the supplier submits these documents.

However credentials of all MSE suppliers will be verified before considering the intended benefits for MSE suppliers as per the provisions of Public procurement policy 2012 and MSMED act 2006 at time of tender evaluation
