Supply of Chemicals to BHEL Anpara Site on F.O.R. Destination Basis

FIRM PRICE ,Price in INR should be quoted for F.O.R. destination ,delivery at BHEL site office,Anpara D,UP
- 3- **EVALUATION CRITERIA:**
Tender will be evaluated based on TOTAL COST TO BHEL, as indicated in Price Bid(PART-"E") of Tender.
Hydrochloric acid, commercial grade, 31% minimum (BIS:265:1993) shall be supplied in Tankers & these tankers may be required to be detained at site for 3 Days and charges of same shall be paid on the basis of per day detention rate. If the tankers is detained beyond 3 Days,detention charges will be reimbursed on the basis of per day detetion rate only.
- 4- **TAXES AND DUTIES**
