SCOPE:

Supply : YES; Erection & Commissioning : NO;

A) GENERAL CRITERIA FOR EVALUATION

1. Vendor should be a manufacturer of LT EPR fire survival cables with copper conductor.
2. In-house capability to carry out all routine, type & acceptance tests (including fire survival test) as per relevant IS/ International standards on LT EPR fire survival cables. In case facilities for fire survival test are not available with the vendor, these tests can be conducted at Govt. Lab/ Govt. approved independent Lab.
3. Capacity of manufacturing 200 km of power/control cables (including non-EPR cables) per month.
4. Availability of type test certificates conducted at independent Lab or witnessed by third party as per relevant IS/ International standards.
5. Manufactured & supplied at least 10 km of LT EPR fire survival cables in single or in combination of two orders in last 5 years.
- 6a. Experience certificates for minimum 2 years of trouble free operation from minimum 2 different end users for LT EPR fire survival cables.
OR
- 6b. Repeat order received from 2 different end users for LT EPR fire survival cables during last 5 years provided the gap between award of two PO's is minimum 3 years.
OR
- 6c. 1 no. experience certificate (as per sl. no. 6a) and 1 no. repeat order (as per sl. no. 6b).
OR
- 6d. Successful execution of a major order (i.e. supply of minimum 5 km of LT EPR fire survival cables in single order) for NTPC EOC, Noida/ EIL/ NPCIL.

Notes :

- i. Vendor(s) not registered with BHEL-PEM Noida for 'LT EPR fire survival cables' shall submit relevant documents in support of above mentioned General Criteria.


B) PROJECT SPECIFIC CRITERIA AGAINST ENQUIRY


1. Bidder(s) already registered with BHEL-PEM Noida for 'LT EPR fire survival cables' need not submit credentials for General Criteria indicated above.


