SCOPE:

Supply : YES; Erection & Commissioning : NO;

A) GENERAL CRITERIA FOR EVALUATION

1. Vendor should have in-house design, fabrication & manufacturing facility.
2. Capability of manufacturing cable trays & accessories for about 40km per month.
- 3a. Vendor has his own galvanization plant.
OR
- 3b. Vendor should get galvanization of cable trays & accessories done from any of BHEL approved galvanizers
- 4a. Manufactured & supplied at least 30 km of cable trays & accessories in single order to 2 different end users.
OR
- 4b. Repeat order received from 2 different end users for cable trays & accessories during last 5 years provided the gap between award of two PO's is minimum 3 years.
OR
- 4c. 1 no. supply experience (as per sl. no. 4a) and 1 no. repeat order (as per sl. no. 4b).
OR
- 4d. Successful execution of a major order (i.e. supply of at least 30 km of cable trays in single order) for NTPC EOC, Noida/ EIL/ NPCIL.





B) PROJECT SPECIFIC CRITERIA AGAINST ENQUIRY


1. After satisfactory fulfilment of all the above criteria/ requirement, offer shall be considered for further evaluation as per NIT and all the other terms of the tender.

ANNEXURE-I

PROJECT SPECIFIC CRITERIA AGAINST ENQUIRY

Regarding Cl.no. 3a and 3b of "General criteria for evaluation", the prospective bidder to note the following:

(I) For NTPC approved vendor as per list enclosed with NIT:

1] Wherever, in remarks column of above bidders list Galvanizer's name is mentioned, the prospective bidder has to get galvanizing done by the same galvanizer only.


2] Wherever, in remarks column of above bidders list Galvanizer's name is not mentioned, the prospective bidder to carry out the galvanizing at their own galvanizing facility only.


3] Bidder can propose additional source of galvanizing with complete credentials along with bid which shall be reviewed and assessed by NTPC. Non-acceptance of additional proposed galvanizers by NTPC shall have no commercial implication to BHEL and the galvanizing requirement shall be governed by clause (1) & (2) above. In case of non-compliance to this requirement, bid is likely to be rejected.


(II) For any prospective Vendor not appearing in NTPC list enclosed with NIT:


Cl.no. 3a and 3b of "General criteria for evaluation", shall be read as below:

The bidder can propose any source of galvanizers including own galvanising facility with complete credentials along with bid which shall be reviewed and assessed by NTPC. Non-acceptance of proposed galvanizers by NTPC shall have no commercial implication to BHEL & the decision of NTPC regarding galvanising requirement shall be binding. In case of non-compliance to this requirement, bid is likely to be rejected.
