

8.00	INSTALLATION & COMMISSIONING				
8.01	Supplier shall take full responsibility to install the machine at BHEL Haridwar and ensure trouble free running and functioning to the full satisfaction of BHEL personnels. All types of accessories and tools for installation and commissioning shall be arranged by supplier. The commissioning shall be done within 14 days of the first call to the vendor from BHEL. 9.00	OPERATING CONDITION:				
9.01	The machine shall be used on shop floor as well as normal roadways. The machine should be able to run satisfactorily on surfaces with scattered metal chips as well as in moderate amounts of stone chips and dust.	Vendor to confirm

10.01	Essential spares and one set of wheels (One number of each type as used in the machine) shall be supplied with each machine. Vendor shall list and provide pricewise breakups of each spare and wheels quantitywise, clearly in the price bid.	Vendor to accept and furnish detailed list of essential spares to be supplied.			
11.00	PACKING				
11.01	Rigid packing to be made for all items of complete machine, all accessories and other supplied items to avoid any damage/loss in transit. When machine is dispatched in containers, all small and loose items shall be suitably packed in boxes.	Vendor to accept

12.01	Guarantee for complete machine, hydraulic system and all supplied accessories/equipments for 24 months from the date of final acceptance.
