



QUALIFYING CRITERIA

Vendor fulfilling the following requirement will be eligible for this tender.

1. **TURN OVER** – Average annual financial turnover during the last three years ending 31 March of the previous financial years should be at least Rs. 66 Lacs. (Audited Balance sheet including Profit & Loss Statement of last three financial years should be enclosed by bidder. In case the Balance Sheet of the last financial year is not yet audited, the un- audited balance sheet of the last financial year can be enclosed along with certificate of CA)

2. **EXPERIENCE** – Experience of having successfully completed similar works* during last 3 years ending last of month previous to the one in which tender is invited should be either of the following: -
 - a. Three similar completed orders, each costing not less than the amount equal to 86 Lacs.

or

 - b. Two similar completed orders, each costing not less than the amount equal to 108 Lacs.

or

 - c. One similar completed order costing not less than the amount equal to 172 Lacs .

(*Definition of similar work" – Supply of Chir/Pine wood loose planks.

Commercial Terms and Conditions

1. This enquiry is being issued to finalize the Rate Contract for supply of Chir/Pine packing wood in the form of Planks, Battens and Sleepers for a period of one year from date of award of Rate contract.
2. It is mandatory to give the elements of ED./CST/other taxes & duties, if any, separately, and not inclusive in the quoted basic price.
3. Inspection shall be carried out by BHEL at BHEL works.
4. Rates to be on firm price basis. No PVC will be acceptable. Offers Received for validity for less than period specified at sl. No. 9 or with any other condition will be commercially-rejected.
5. Quoted rate must be on F.O.R BHEL Jhansi basis inclusive of freight & insurance. No other Terms shall be accepted.
6. **Payment Terms: 100%** payment after 60 days of receipt and acceptance of material at BHEL works. The suppliers who are availing HDFC / SIDBI bill discounting facility (pay by BHEL in about 120 days from the date of invoice) with us will continue to get this facility. However, due to funds problems, this cannot be extended to other suppliers. For such suppliers standard payment terms shall be applicable for deciding tender. The bidders who are covered under MSMED Act- 2006 & quoted 45 days of payment after acceptance of material will also be treated as standard terms of payment. Both payment terms will be treated at par. The offer received with any other terms of payment will not be accepted.
7. L-1 vendor shall be decided on overall landed rate basis.
8. Please quote the rate in 'per cubic meter' basis.
9. Validity of offer must be **120 days** from the date of opening of techno commercial bid and validity of price must be 60 days from opening of price bid / reverse auction.
10. BHEL reserves the right to go for reverse auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.
In case BHEL decides to go for reverse auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the reverse auction. Those bidders who have given their acceptance to participate in reverse auction will have to necessarily submit 'online sealed bid' in the reverse auction. Non-submission of 'online sealed bid' by the bidder will be considered as tampering of the tender process and will invite action BY BHEL as per extant guidelines-in vogue.

TERMS & CONDITIONS OF REVERSE AUCTION

Against this enquiry for the subject item / system with detailed scope of supply as per enquiry specifications, BHEL may resort to "REVERSE AUCTION PROCEDURE" i.e., **ON LINE BIDDING (THROUGH A SERVICE PROVIDER)**. The philosophy followed for reverse auction shall be English Reverse (No ties).

1. For the proposed reverse auction, technically and commercially acceptable bidders only shall be eligible to participate.
2. Those bidders who have given their acceptance for Reverse Auction (quoted against this tender enquiry) will have to necessarily submit 'online sealed bid' in the reverse auction. Non-submission of 'online sealed bid' by the bidder for any of the eligible items for which techno-commercially qualified, will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.
3. BHEL will engage the services of a service provider who will provide all necessary training and assistance before commencement of on line bidding on internet.
4. In case of reverse auction, BHEL will inform the bidders the details of Service Provider to enable them to contact & get trained.
5. Business rules like event date, time, bid decrement, extension etc. Also will be communicated through service provider for compliance.
6. Bidders have to fax the Compliance before start of Reverse Auction. Without this the bidder will not be eligible to participate in the event.
7. In line with the NIT terms, BHEL has provided the calculation sheets which will help to arrive at "Total Cost to BHEL" for each of the bidder to enable them to fill-in the price and keep it ready for keying in during the Auction.
8. Reverse auction will be conducted on scheduled date & time.
9. At the end of Reverse Auction event, the lowest bidder value will be known on auction portal.
10. The lowest bidder has to fax / e-mail the duly signed and filled-in prescribed format for price breakup including that of line items, if required as provided on case-to-case basis to Service provider within two working days of Auction without fail.
11. In case BHEL decides not to go for Reverse Auction procedure for this tender enquiry, the Price bids and Price impacts, if any, already submitted and available with BHEL shall be opened as per BHEL's standard practice.
12. Bidders shall be required to read the "Terms and Conditions" section of the auctions site of Service provider, using the Login IDs and passwords given to them by the service provider before reverse auction event. Bidders should acquaint themselves of the "Business Rules of Reverse Auction", which will be communicated before the Reverse Auction.
