



DETAIL OF WORK

1. SCOPE OF WORK:

The work mainly comprises of as follows :

1 Preparation of earth pits and laying of earth strips.

1.1 Preparation of earth pits: Excavation of earth pit of size as per given drawing receiving and shifting of material from store to work place, fixing of electrodes of size as per given drawing and backfilling of pit. All the material shall be provide by BHEL.

1.2 Laying of connections of earth strips: Receiving and shifting of material from store to work place, laying and connecting of earth strip from earth pit to concerned installation in all respect .

2 Miscellaneous electrical wiring work

2.1 Batten point wiring: Wiring will be done as per instruction of area in-charge. All material will be Issued from WE&S /Township store

2.2 Conduit point wiring: Wiring will be done as per instruction of area in-charge. All material will be Issued from WE&S /Township store.

2.3 Fixing and connecting of fan and tube fittings: Fixing of fan and tube fitting will be done as per Instruction of area in-charge. All material will be issued from WE&S /Township store .Assembly of fan also to be done by contractor

2.4 Fixing and connecting of Distribution Board: Fixing of Distribution Board will be done as per Instruction of area in-charge. All material will be issued from WE&S /Township store .Assembly of fan also to be done by contractor.

2.5 Laying and connecting of sub – main: Laying of Sub –Main will be done in township. The work includes removing of old Sub-Main and laying of new Sub-Main. All material will be issued from WE&S /Township store.

2.6 Fixing & connecting of High Bay light Fitting - Fixing of light fittings will be done as per Instruction of area in-charge. All material will be issued from WE&S store .Assembly of fitting is also to be done by contractor(In factory only).

- 2.1 All the tools and tackles , spares including consumable like gear oil, grease, cotton waste, Electrical items, gas cutting, welding and machining facilities etc. shall be provided by BHEL- Jhansi free of cost.
- 2.2 The contractor for the work mentioned above shall maintain sufficient staff. Work shall be done in first and Second shifts. However during production/ emergency, work in third shift may also be done in some areas as instructed by the in charge maintenance.
- 2.3 A responsible and competent supervisor shall be posted to co-ordinate and supervise the work.
- 2.4 Contractor shall maintain all records like work requisitions form, spare list, and all other records pertaining to his work.

3.0 DEPLOYMENT OF MANPOWER

To carry out the above mentioned work during total contract period the contractor will deploy adequate numbers of workers with a adequate knowledge and experience with an approval of section / maintenance in-charge.

4.0 URGENT WORK

- 4.1 The contractor shall have to comply with the priorities fixed by the maintenance in charge or for taking urgent repair work .

5.0 CANCELLATION OF CONTRACT IN FULL OR PART

Contract shall be canceled in full or part if the contractor:

- (a) At any time makes defaults in proceeding with the work with due negligence and continuous to do so after a notice in writing or 7 days from the AGM (WE&S) BHEL, Jhansi.
- (b) Commits defaults in complying with any if the terms and conditions of the contract.

6.0 PERIOD OF CONTRACT

The period of contract will be for one year (Twelve months) or completion of total work whichever is earlier.

7.0 TERMS OF PAYMENT

- 7.1 Payment will be made every month on submission of work done during the month, satisfactory performance report from the in charge maintenance along with Bills.
- 7.2 Income Tax will be deducted from the each bill. This will be as per guideline of Govt. of India. At present 2% Income Tax will be deducted.

8.0 GENERAL TERMS & CONDITIONS

- 8.1 Contract shall keep all staff orderly in proper uniform and arrange to provide them the work of repair/ manufacture of spares in their idle times.
- 8.2 No foreign/used/unused/scrapped/broken parts shall be left on area.
- 8.3 All used/worn-out/scrapped/replaced spares/parts shall remain the property of BHEL, Jhansi. These items shall be return to WE&S store.
- 8.4 BHEL, Jhansi shall not be liable for any compensation what so ever in the event of accident/injury to the persons employed by the contractor, however, First Aid facility shall be rendered free of cost.
- 8.5 Utmost care should be taken by the contractor to repair the items in proper way & with Quality workman ship so as to satisfy the safety requirements as per Factory Act, 1948 Section 19 & U.P.Factories Rules 1950 Rule 55-A & subsequent amendments enforced from time to time.
- 8.6 As our company being accorded with ISO 9001, ISO 14001 and OHSAS 18001, contractor are required to carry out work confirming to our quality standards along with necessary documentation/paper work.
- 8.7 In the event of requirement of material/ spares etc. contractor will approach maintenance in charge along with required paper work, which will authorize/counter sign the same for withdrawal. - Above tender is in two Bid System (Techno Commercial Bid & Price/ Rate Bid).
1. The tender is to be processed in two parts viz. 1) Techno Commercial bid 2) and price/rate bid. The Technical Bid Application (Annexure - I) and its enclosures (along with the Contractor's Obligations, General Terms & Conditions and copies of qualifying requirements) must be submitted in one sealed envelope superscripted as "Tender for Miscellaneous Electrical work in BHEL-Jhansi factory & Township(Work Contract) . TECHNOCOMMERCIAL bid". EMD/Cost of Tender Document or Documents required as per qualifying requirements must be enclosed. After evaluation of the Technical Bid which may involve visit to the tenderer's / clients place by authorized officials, price bids of only those tenderers who are technically found suitable will be opened on a subsequent date which will be informed to the concerned whose technical bid has been accepted, in advance for witnessing the Price Bid opening.

The evaluation of the Tender will be carried out as follows:

1. BHEL officials may visit the bidders' office & their client's place to evaluate the capability and assess the performance.
2. Capability of the Contractor will be assessed on the basis of employees including Supervisors on their rolls, machinery, equipments in its possession, previous track record, experience in other organizations, etc.
3. Price Bids will be opened or participation in Reverse auction will be allowed to only Techno-Commercially accepted bidders.
4. The contractor shall be awarded the work on overall L-1 basis if otherwise not specified in the tender document.
5. In case of tie between two or more than two bidders for L1 price . Bids shall be called for discount on price offered in sealed envelope from all the L1 bidders. In case of discrepancy in words and figures offered in price bid the decision shall be taken based on annexure "V"

CONTRACTOR'S OBLIGATIONS

A) CONTRACTUAL:-

Towards selection, control and supervision of employees:-

1. Contractor shall decide the number of employees to be deployed for execution of the work awarded to him and he or his authorized representative will be solely entitled to instruct such about the manner of carrying out the work as per the prescribed specifications and quality plan.
2. Contractor shall supervise the work allotted to him and to be carried out by his employees.
3. Contractor will ensure that the job is executed through his employees on his rolls and under no circumstances the contractor will deploy any casual employee to carry out the job nor shall sub-contract the job without prior written permission.
4. **Age of workers:** The contractor shall not employ any person who has not completed his 18 years. Also age of worker deployed should not exceed 60 years.
5. Contractor to ensure that the employees deployed in the premises of BHEL are physically and mentally fit and do not have any criminal record. Such employees should possess requisite skill, proficiency, qualification, experience etc. acceptable to concerned department.
6. **Discipline:** The Contractor shall be responsible for the discipline of his own employees deployed under the contract. In case of any loss to the BHEL Jhansi on account of indiscipline of employee then such loss shall be assessed and recovered from the running bills of the contractor or from the security deposit.
7. The contractor, on advice of authorized BHEL official, shall immediately remove any person employed by him, who may in the opinion of such authorized BHEL official is involved in misconduct. Such person shall not be re-employed by the contractor without prior permission.
8. Contractor will keep watch on his employees and he will be liable for any pilferage / loss to BHEL due to acts of omission and commission by his employees. Similarly, liability for any compensation to outsiders on account of any act of omission and commission by the employees deployed by the contractor shall lie exclusively with him.
9. Contractor to ensure that all precautions are taken for safety of his employees and equipments.
10. **Record Keeping:** Contractor to maintain appropriate records of his employees deployed to carry out the job(s). Contractor shall maintain neatly written, complete and legible registers, records, reports and returns for inspection by various authorities at short notice.

11. **Uniform:** The contractor shall be responsible to provide to his workers uniform and safety gears such as shoes, helmet and PPE . The uniform should be dark blue trousers and light blue shirt for males and dark blue trousers/salwar and light blue kurta/kameez/top for female. The uniform should have logo of the contractor's firm/ company which shall be affixed by the contract labor on the left side of his pocket. The uniform shall be kept in neat, tidy and wearable condition. The stitching and logo charges should be borne by the contractor. Contractor shall ensure that the employees are in neat and tidy uniform and safety gear on duty. Penalty of 5% of monthly bill may be imposed if the workers are not found in prescribed uniform and safety gears.
12. **Bus Pass :** Contractor may apply for providing bus pass facility to his workmen. BHEL will consider such applications based on merits and availability of seats. Contractor would be responsible for depositing bus pass charges and penalties (if applied) of his/her workmen/staff etc. BHEL would have the right to deduct/recover the same in case of default by the contractor/supplier.
13. In the event of termination of contract for any reason whatsoever, the contractor shall withdraw all his employees from the establishment of BHEL. In case contractor decides to terminate services of his employees, he should settle all terminal dues required.
14. **Tools, tackles and materials :** Contractor shall provide to his employees all tools, tackles, material, equipments as specified in contract and maintain the same to carry out the job under the contract at his risk and cost. BHEL shall not have any liability for these tools, tackles, equipments or material.

B. Towards statutory liability

1. As mentioned in the terms and conditions enclosed as Annexure 'G' of this contract.
2. Contractor shall indemnify BHEL against all claims by statutory authorities and losses under various Labour Laws, statutes or any civil or criminal law in connection with employees deployed by him.
3. Contractor shall be responsible for making payment of wages before expiry of 7 days from the last day of wage period (wage period shall be from 1st day of the month to the last date of the month) and to ensure disbursement of wages in the presence of the authorities representative of contract operating division who shall record under his signature at the end of entries in the Register of wages.

C. Towards Finance

Contractor to arrange his own finance for carrying out the job including supply of tools, tackles and equipments, if required, to his employees, materials, payment of wages to his employees etc. Rates to be as per price bid.

1. Security Deposit




4.0 Appointments and Entry in Factory Premises:

- 4.1 The contractor shall submit the following to HR, contracting department and CISF.
- The details of the worker proposed to be deployed.
 - Character certificate issued by District Magistrate's Office or Proof of remittance of fees for character certificate at District Magistrate's Office. Further he should submit the character certificate within 60 days failing which he will be discontinued.

In case of non-conformities/errors/discrepancy are observed between the quoted prices in the figures and that in words, following guidelines shall be followed:

- (a) If, in the price structure quoted for the required goods /service /works, there is discrepancy between the unit price (which is obtained by multiplying the unit price by the quantity), the unit prices shall prevail and the total price corrected accordingly. Unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
- (b) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotal shall prevail and the total shall be corrected and
- (c) If there is a discrepancy between words and figure, the amount in words shall prevail unless the amount expressed in words is related to an arithmetic error, in which case the amount in figure shall prevail subject of (a) and (b) above.
- (d) If there is such discrepancy in an offer the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance on above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.
