Bids of only those bidders shall be evaluated who meet the Technical as well as Financial pre-qualifying requirements. Credentials of the bidders meeting the pre-qualifying requirements shall be taken up with customer for approval. Price Bid of only BHEL and customer approved vendors shall be opened for evaluation.

11. **Indigenous bidders to indicate their import content (CIF) in their price bid and Nil Custom duty shall be considered by them. As no CIF has been consumed till date, no ceiling limit is being put at the time of enquiry. However the same will be reviewed during evaluation of offers and bidders will be informed accordingly.**
12. **Bidder to note that this is a conditional enquiry for those who are not registered in BHEL PEM, the price bid (Part-II) opening/RA is subject to following:**
 - a) **Approval of bidder by the BHEL.** The vendors which are not registered with BHEL-PEM have to download the Supplier Registration Form (SRF) from www.bhelpem.com after viewing PQR requirement on www.bhelpem.com and submit the same duly filled in along with credentials – experience list, performance certificates and other statutory data with their bids for vendor registration.
 - b) **Approval of bidder by Customer.** Same shall be taken up by BHEL with customer based on the credentials/reference list. Hence Bidders are requested to submit the following as part of their credentials on or before technical bid Part-I opening:-
 - i. Reference list indicating PO details, customer name, PO date, execution date etc.
 - ii. Performance certificate issued by the clients. Repeat orders by same customer may be considered as performance certificate after a reasonable lapse of time period before the repeat order.
 - iii. Bidders are requested to fill up their details in NTPC format of Sub – Supplier Questionnaire attached with enquiry.
13. Indigenous bidders have to quote freight charges in percentage of their quoted Total ex-works prices.
14. BHEL PEM reserves the right to go for **Reverse Auction**, through BHEL appointed service provider, instead of opening sealed price bids submitted along with Part-I. This would be decided after techno-commercial evaluation. In view of above, Bidders are requested to quote their most competitive prices as **no negative impact** on account of non-conduction of RA shall be asked for.
