14. Indigenous bidders to note that CIF allocation is not applicable for the subject package for the subject project.

15. PRE-QUALIFICATION REQUIREMENT:-

Bidders are requested to fill up the details in "TECHNICAL AND FINANCIAL PRE-QUALIFYING REQUIREMENT" and also to submit the credentials. The bidders, who are already registered with BHEL PEM for the tendered package *without any financial limit*, need not submit the Financial PQR. They will be considered qualified on Financial PQR based on their registration with BHEL PEM. In case of limit, the registered bidder may submit the documents required for review of limit alone, if the bidder wants re-assessment of the limit.

Bids of only those bidders shall be evaluated who meet the Technical as well as Financial pre-qualifying requirements. Credentials of the bidders meeting the prequalifying requirements shall be taken up with customer for approval. Price Bid of only BHEL and customer approved vendors shall be opened and same shall be covered in NIT.

16. Reverse Auction: BHEL/ PEM reserves the right to go for Reverse Auction, through BHEL appointed service provider, instead of opening sealed price bids submitted along with Part-I. This would be decided after techno-commercial evaluation. (Refer Clause No. 15.0 of Instruction to Bidders, GCC REV 05).

17. Bidder to note for compliance that this is conditional enquiry, the price bid (Part-II) opening/RA is subjected to

- Approval of bidder by the BHEL.
- Approval of bidder by Customer. Same shall be taken up by us with customer based on the credentials/reference list. So you are requested to submit the following upgrading on or before technical bid Part-I opening:-
 - Reference list indicating PO details, customer name, PO date, execution date etc.
 - Performance certificate issued by the clients.

18. Indigenous bidders have to quote freight charges in percentage of their quoted ex-works prices.
19. As per the customer requirement, either DC Battery (Lead Acid) or DC battery (Ni-Cd) is required. Hence, we will prefer any one of the battery among the two which will be cheaper in cost. Bidders are requested to quote considering the same.
20. Bidder has to submit "NO DEVIATION CERTIFICATE FOR COMMERCIAL TERMS AND CONDITIONS AS PER GCC (05), SCC (REV00) AND NIT". In case of deviations, bidder to clearly mention the same with their techno-commercial offer.
